The petitioner, who has been undergoing judicial custody since 01.03.2026, preferred this application for grant of regular bail in connection with Rafiganj P.S. Case No.507/2025 instituted for the offence u/s 191(2), 190, 126(2), 115(2), 109(1), 329(2) 351(2), 352 of Bhartiya Nyaya Sanhita, 2023. A copy of the bail petition has been served upon the ld. P.P. for the State.

The brief facts of the case are that on 14.12.2025 at about 3 AM, informant has gone to see his crop then he saw that Azam Qureshi's animals were eating his crop. When he went to inform to Aazam Kureshi (Petitioner herein) about eating crop by his animals then Aazam Kureshi, Neyaz Kureshi, Nehal Kureshi, Kadir Kureshi and Sahjadi Khatoon altogether assaulted to the informant by iron rod in which he sustained head injury. When his brother came to rescue him, then Sajid Kureshi also assaulted his brother.

Learned counsel for the petitioner has submitted that the petitioner is quite innocent. Petitioner has been falsely implicated in this case. Nothing has happened as alleged by the informant. He has further submitted there is a counter case filed by the petitioner against the informant vide Rafiganj P.S case No.508/2025. It is lastly submitted that petitioner is languishing in custody since 01.03.2026. On these scores, it is prayed that the petitioner be enlarged on bail. .

On the other hand, learned P.P. for the State opposed the prayer for grant of bail to the petitioner.

Heard learned counsel for the petitioner and learned P.P. for the State.

There is general and omnibus allegation against five accused persons including the petitioner regarding injury caused to the informant and his brother. The dispute has been arisen regarding drainage of water. There is a counter FIR vide Rafiganj P.S case no. 508/2025. From perusal of injury report, it is found that injury sustained by Sajid Quiraishi is simple in nature but the injury sustained by the informant was found to be grievous. However, the aforesaid injury was caused by hard and blunt substance. It is mentioned at para 46 of the case diary, petitioner is having no criminal antecedent. Petitioner has been undergoing judicial custody since 01.03.2026.

Considering the aforesaid observation, bail petition filed on behalf of the petitioner is hereby **allowed** subject to furnishing bail bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of the like amount each to the satisfaction of the learned court below.
