The petitioners, who have been undergoing judicial custody since 06.02.2026, preferred this application for grant of regular bail in connection with Aurangabad (Town) P.S. Case No. 97/2026 instituted for the offence u/s 303(2), 317(2) of Bhartiya Nyaya Sanhita, 2023. A copy of the bail petition has been served upon Ld. P.P. for the state

The brief facts of the case are that on dated 05.02.2026 at about 09:45 hours, when the informant came out of his house, he saw two boys throwing a battery from inside the shop. On raising alarm, both boys tried to flee, but they were apprehended. They were caught outside along with a motorcycle without a number plate. On inquiry, they disclosed their names as Suraj Kumar and Ajit Kumar (petitioners herein).

It has been submitted by the learned counsel appearing for the petitioners that the petitioners are quite innocent and have committed no offence. They have been falsely implicated in this case. Petitioner No.1 Suraj kumar is having four criminal antecedents and petitioner no.2 Ajit Kumar is having one criminal antecedent. It is lastly submitted that the petitioners have been undergoing judicial custody since 06.02.2026. It is therefore prayed that the petitioners be given the privileges of bail.

grant of bail to the petitioner.

Heard learned counsel for the petitioner and learned P.P. for the State.

Petitioner was found involved in stealing of battery from a shop. However, on shouting raised, petitioners were caught on the spot. During course of investigation, it is found that the Petitioner no.1 Suraj Kumar is having six criminal antecedent and on the other hand, Petitioner no.2 Ajit kumar is having one criminal antecedent. Petitioners have been undergoing judicial custody since 06.02.2026.

Considering the nature of allegation and the fact that the petitioners have been undergoing judicial custody last more than 2 months. Hence, bail petition filed on behalf of the petitioners is hereby **allowed** subject to furnishing bail bond of Rs. 20,000/- (Rupees Twenty Thousand) with two sureties of the like amount by each petitioners to the satisfaction of the learned court below with a further direction that one of the bailor shall be the family member of the petitioners.
