File was taken up on 24.07.2026 on application filed by applicant Gurpreet Singh to accept bail bonds in terms of order dated 21.07.2026 passed by Hon'ble Supreme Court. Next date of hearing was for 28.07.2026 i.e. today. Perusal of clause no.6 of impugned bail order revealed that to comply with said order applicant is to be produced before learned trial Court. Accordingly at request of applicant production warrant of applicant was issued for today and applicant-accused Gurpreet Singh has been produced in custody today. Now an application has been filed by complainant that applicant Gurpreet Singh holds a valid passport bearing no.M8434490 and has Visas for different countries and that accordingly in terms of clause no.8 of impugned bail order applicant is required to surrender his passport before trial Court till conclusion of trial or directed

otherwise. Bail order stands confirmed by Ahlmad from website of Hon'ble Supreme Court. In view of same applicant is ordered to be released on bail on furnishing bail bonds in sum of ₹1,00,000/- with one surety in like amount. Today bail bonds and surety bonds have not been furnished. Thus application dated 24.07.2026 stands disposed off accordingly.

No prosecution witness is present. Summons issued to PW listed at serial no.18 and 19 not received back either served or unserved. Hence fresh be issued *returnable* for 20.08.2026. Accused Tinu Anand, Gurpreet Singh, Kamal Verma and Bobby @ Bobby Chappa in custody stands remanded to judicial custody till date fixed.

Reply to application under Section 94 of BNSS read with Section 348 BNSS for production of record and summoning concerned witnesses by way of additional evidence not filed as learned proxy counsel seeks an adjournment on ground that regular counsel is not available in view of resolution bearing no.A/3975/DBA/LDH dated 28.07.2026 passed by District Bar Association Ludhiana. Be filed on date fixed and also for arguments thereon.
