| <b><u>Dated</u></b><br><b><u>31.07.2026</u></b> | <p>A regular bail petition has been filed on behalf of the accused/petitioner namely <b>1. Ramji Yadav, and 2. Pappu Yadav</b>, who has been in judicial custody since 01.07.2026 in connection with Haspura PS Case No. 227/2026 under Sections 126(2), 115(2), 117(2), 118(1), 303(2), 352, 351(2), 109(1), 3(5) of the BNS and Sections 3 (1) (r) (s), 3 (2) (va) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989. The case diary has been received. After furnishing the copy of the bail petition to the Special Public Prosecutor and pressed today. The informant is absent.</p> <p>The learned counsel for the accused/petitioners reading out the contents of the F.I.R., submitted that the accused/petitioners are innocent and they have committed no offence. No any bail petition has earlier been filed on behalf of the petitioner either before this court any any higher court. It is further submitted that no any such occurrence has taken place as alleged rather the reality is that the petitioner Ramji Yadav is a poor man who supports his family by driving a tempo. On 30.06.2026, the petitioner Ramji Yadav was returning home driving a tempo, when the sons of Mitlilesh Paswan and Rajesh Paswan of the village were hanging from the back of the tempo, whom he was trying to drive away by scolding them, then Mithilesh Paswan and Rajesh Paswan started abusing and beating them, on hearing hulla, Mithilesh Paswan's mother, wife and sister-in-law also came and his son and wife who came to save the petitioner Ramji Yadav were beaten with bricks and the petitioner was injured by thrashing him with lathi for which the petitioner has lodged Haspura PS Case No. 228/2026, in defence of the same the present case has been registered against the petitioners. He further submitted that there is no direct allegation of assault and theft and in such circumstance Section 109(1), 303(2) of the BNS is not made out and save and except Section of SC/ST Act, other sections areailable in nature. The informant did not sustained injury rather the injury is concocted to make the case non-bailable. He further submitted that the petitioner are minority in their village and informant's side are in majority due to which put the pressure upon the petitioners, a false case has been lodged and they were falsely implicated in this case. The petitioners have no criminal history. The petitioners have contended that there is no chance of his absconding and they are ready to fulfill the conditions of bail and it has been prayed to extend the</p> |  |

| <p><b><u>Cont....</u></b><br/><b>31.07.2026</b></p> | <p>privileges of bail to the accused/petitioners.</p> <p>Per-contra, the learned public prosecutor has opposed the bail application of the accused/petitioners and the allegations are serious in nature.</p> <p>Heard and perused the case diary which has already been received in total 78 paragraphs till 28.07.2026. The thrust of allegation against the petitioners is of assaulting the informant by means of khanti on his head and as well as brother and wife of the informant. Further, the allegation of snatching the golden Bali(ear ring) of the wife of informant has also been made against the petitioners. The informant in his restatement in para-5 and other witnesses in para-6,7 and 8 of case diary have supported the case and has named the present petitioners in assaulting the informant and other family members. However, on perusal of the injury reports of the victims which are separately annexed with the case diary, it appears that the informant has sustained single injury on his right temporal head, wife of informant has complaint of pain mid skull and pain and swelling on the right hand little finger has been found on the person of Sitachameli Devi. The supplementary injury report of Sitachameli Devi has not been produced till date by the Ld. Spl. PP. The other injuries found on the person of victims have been found simple in nature caused by hard and blunt substance. The present petitioners have been languishing in judicial custody since 01.07.2026. As para-3 of the bail petition, the petitioners have clean criminal antecedent and nothing contrary is also available on the case diary.</p> <p>Considering, the facts and circumstances of this case as discussed above, as well as the period of detention undergone by the accused-petitioner, the bail application filed by abovenamed accused-petitioners namely <b>1. Ramji Yadav, and 2. Pappu Yadav</b> is hereby <b>allowed</b>. The above named accused-petitioners are directed to be enlarged on bail, upon furnishing their bail bonds of Rs. 20,000/-(Ten thousand) each with two sureties of the like amount to the satisfaction of the court.
