**ORDER**

1. *Yearning for an order of emancipation the bail petition has been filed by the petitioners, who are booked in Suiya Police Station Case No. 68 of 2025, for the offence allegedly committed under Sections 191(2), 191(3), 190(1), 103(1), 352, 351(2), 3(5) of BNS and are confined in jail since 29.01.2026.*

2. *The case of prosecution is based upon a gravamen filed by one Prakash Yadav with the allegations that in the mid-night of 02.08.2025, he along with his father and brother were sitting beside his hotel. All of sudden, due to previous land dispute accused persons, 1. Firdos Ansari, 2. Habib Ansari, 3. Jumrati Ansari, 4. Rajjak Ansari, 5. Mansur Ansari, 6. Ajmer Ansari, 7. Altaf Ansari @ Chhotu Ansari, 8. Anwarul Ansari, 9. Dabbu Ansari and three to four unknown persons came having Lathi, Danda, knife, gun and pistol in their hands and attacked the informant, his father and his brothers. Accused Habib Ansari provoked others to kill informant's father upon which all the accused persons dragged his father to paddy field and accused Firdos Ansari assaulted his father with knife and murdered him.*

3. *In oral arguments, the learned counsel for petitioner submitted that the accused/petitioner is confined in jail since 29.01.2026. It is further submitted that the petitioner has no criminal antecedent. It is argued that in some other cases, on the basis of the confessional statement of another accused, he has been*

*dragged in this case.*

4. *In counter, learned Public Prosecutor for the State stoutly opposed the bail application. Drew attention of this court on para no. 58, 90, 91, 99 according to which there is clear involvement of all the accused persons in this murder.*

5. *Heard submissions and perused the record. This is a case of broad daylight murder, and the case is still at its nascent stage of investigation, as no charge-sheet has been filed. This court is well disposed with the submission of learned Public Prosecutor, therefore, at the stage, this court is not inclined to grant bail; resultantly it is dismissed.*

6. *File be consigned to the record room and that of trial court be sent back with a copy of this order.*

7. *Keeping in view the General Order no. 1 of 1991 (Criminal) dated 07.03.1991, the certified copy of FIR, if desired, be returned back to the petitioners on placing the xerox copy thereof on record.*
