ORDER

- 1. Yearning for an order of emancipation the bail petition has been filed by the petitioner, who is booked in Belhar Police Station Case No. 358 of 2024, for the offence allegedly committed under Sections 191(2), 190, 126(2), 115(2), 121(1), 221, 132, 352, 351(2), 303(2), 324(4), 326(f) of BNS and is confined in jail since 18.01.2026.*
- 2. The case of prosecution is engendered upon a gravamen filed by one Pradeep Kumar Choudhary, Police Sub-Inspector of Belhar police station with the allegations that on 07.10.2024, he conducted raid in the house of Mithun Shekh, named in Belhar Police Station Case No. 319 of 2024. During course of raid, he along with his team nabbed Mithun Shekh in his house. On the voice raised by Mithun Shekh, the accused/petitioner along with ten others and 8-10 unknown attacked the raiding party and caused hurt to informant and other police personnel with blackjack, sticks, bricks and stones for getting freed Mithun Shekh from the police. The accused persons also damaged the police vehicle by throwing bricks and stones.*
- 3. In oral arguments, the learned counsel for petitioner submitted that one co-accused named Guriya Kahtun has been granted bail by this court vide Bail Petition No. 1409 of 2025, and other co-accused named Nezam Mian @ Nizam Shekh, Munni Begum @ Munni Bibi, Biram Mian, Aftariya Shekh @ Avtari Shar an Rani Khattoon have been granted pre-arrest bail by the Hon'ble High Court of Judicature at Patna, vide criminal misc. no. 31209 of 2025. The case of present petitioner is on lesser footings as he neither belongs to the family or village of main accused Mithun Shekh. He*

is confined in jail since 18.01.2026.

4. In counter, learned Public Prosecutor for the State stoutly opposed the bail application.

5. Heard rival submissions and perused the record. It is indubitable that one co-accused named Guriya Kahtun has been granted bail by this court vide Bail Petition No. 1409 of 2025, and other co-accused named Nexam Mian @ Nizam Shekh, Munni Begum @ Munni Bibi, Biram Mian, Aftariya Shekh @ Avtari Shar an Rani Khatoon have been granted pre-arrest bail by the Hon'ble High Court of Judicature at Patna, vide criminal misc. no. 31209 of 2025. It is also indubitable that the present petitioner is neither of the village of main accused Mithun Shekh, whom allegedly the accused person tried to free from the police custody nor is his relative. The present petitioner is confined in jail since 18.01.2026, whereas the chargesheet has been filed and the cognizance has been taken by the learned trial court. Now in the opinion of this court, no fruitful purpose of any kind is going to be served by detaining anymore the accused in jail; resultantly, he is ordered to be emancipated on bail on his furnishing bail bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount to the satisfaction of trial court. Out of the two sureties, one will be of the same village or close relative of petitioner. The petitioner shall file an undertaking that he shall personally appear on each and every date of hearing and after third absence in total, his bail will be cancelled.

6. File be consigned to the record room and that of trial court be sent back with a copy of this order.

7. Keeping in view the General Order no. 1 of 1991 (Criminal) dated 07.03.1991, the certified copy of FIR, if desired, be returned back to the petitioner on placing the xerox copy thereof on record.
