ORDER

1. *Apprehending arrest the petitioner has preferred this pre-arrest bail application who is booked in Rajoun Police Station Case No. 552 of 2023, for the offence allegedly committed under Sections 341, 323, 379, 504, 506/34 of IPC.*

2. *The case of prosecution is engendered upon an application filed by one Shiv Nandan Kumar Yadav with the allegations that on 31.10.2023, at about 09:30 am, his villagers named (i) Subodh Yadav, (ii) Bipin Yadav, (iii) Ashok Yadav, (iv) Devanand Yadav, (v) Kundan Yadav, came his house and started abusing. When he refused to do so, Subodh Yadav gave a blow of Lathi on his head, resultantly his head ruptured and blood started oozing. When Kasbo Kumar Yadav came to rescue, Subodh Yadav also gave a blow of iron rod on his head. When his father came to rescue, Kundan Yadav and Devanand Yadav gave a blow of axe, resultantly his father became injured. When his brother Raj Kumar came to rescue, Bipin Yadav and Ashok Yadav gave a blow of blackjack. All the persons threatened him not to go to the police. While leaving, they snatched silver chain from his neck and took out money from his pocket.*

3. *In oral arguments, learned counsel for the petitioner submitted that he has falsely been implicated in this case whereas there is no injury on any vital part or no grievous injury of any kind on the persons of any of the alleged injured. It is further argued that co-accused Subodh Yadav, Bipin Yadav and Kundan Yadav @ Kundan Kumar have been granted bail vide Criminal Miscellaneous No. 45407 of 2024 by the Hon'ble High Court of Judicature at Patna and the case of the present petitioner is on similar footing.*

4. *In counter, learned Public Prosecutor for the State opposed the pre-arrest bail application.*

5. *Heard submissions and perused the record. The record reveals that co-accused Subodh Yadav, Bipin Yadav and Kundan Yadav @ Kundan Kumar have been granted pre-arrest bail vide Criminal Miscellaneous No. 45407 of 2024 by the Hon'ble High Court of Judicature at Patna. And the case of present petitioner is also on similar footings. Therefore, this court sees no reason to decline petition of this petitioner, hence is inclined to grant the petitioner privilege of bail; resultantly, it is allowed. It is, therefore, ordered that upon arrest or surrender of the petitioner within fortnight of receiving the instant order the petitioner be admitted to anticipatory bail upon furnishing bail bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount to the satisfaction of trial court subject to condition as laid down under Section 482(2) of the BNSS. Out of the two sureties, one will be of the same village or close relative of petitioner.*

6. *File be consigned to the record room and that of trial court be sent back with a copy of this order.*
