	<u>13.08.2026</u>	Bail petition filed on behalf of the accused namely Niranjan Yadav, who is in custody since 26.06.2026, in connection with Shambhuganj P.S. Case no.- 189/2026 under section 30(a) of the Bihar Prohibition and Excise Act is pressed today. The case of the prosecution in brief is that on 25.06.2026 at about 10:15 PM, informant along with other police personnel proceeded for conducting raid. In due course, they received a confidential information that a person on a motorcycle carrying country made liquor in sky color bag and dikki of motorcycle was coming. To verify the same they reached near Kamardih Mor and started checking vehicles. After seeing the police checking one person on a motorcycle bearing reg. no. BR 08N 1364 tried to escape. However, they chased and nabbed him. On search of motorcycle altogether 36 litres of illicit country made liquor was recovered from dikki and a sky color bag kept on the tank of aforesaid motorcycle. On enquiry, driver disclosed his name as Niranjan Yadav. Heard the learned Defence counsel as well as the learned Spl.P.P. for the State. Learned Counsel for the petitioner has submitted that the petitioner is innocent and is falsely implicated in this case due to dirty politics of the locality and also at the instance of his enemies. Earlier no other bail petition has been filed on behalf of the petitioner either before this Court or before the Hon'ble High Court. No motorcycle made liquor has been recovered from the conscious possession of the petitioner. All allegations are false and concocted. No occurrence as alleged has taken place. Petitioner is in custody since 26.06.2026 & he has no criminal antecedent. So, he may be released on bail. On the other hand, Learned Spl. P.P. opposed the bail petition. Heard both the parties and perused the case record and seizure list available on record. It transpires that there is allegation against the petitioner that 36 litres of illicit country made liquor was recovered from dikki and a sky color bag kept on the tank of aforesaid motorcycle, on which he was riding. It further transpires that there is no criminal antecedent of the accused, as per para 8 of

case diary. Accused is in custody since 26.06.2026.

After considering the facts & circumstances of the present case, recovery of low amount of country liquor & period of custody, present bail application of the accused is allowed and he is directed to be released on furnishing bail bond of Rs. 10,000/- with two sureties of like amount subject to the satisfaction of this Court ***and subject to further condition that one of the bailors shall be close relative of accused/petitioner and he will also file an undertaking stating therein that he will not indulge in similar kind of offence in future and if found then the prosecution has liberty to move an application for cancellation of his bail bond and he will also co-operate in trial of the case, made himself physically present or well represented on each & every date which will be fixed in case record.***
