Heard the learned counsel for the accused/petitioners namely 1. **Mahendra Choudhary** s/o-Dhannu Choudhary and 2. **Raj Kumar Choudhary @ Latto Choudhary** s/o-Mahendra Choudhary Both R/o-village-Teghra Purani Bazar Ward No.17, P.S.- Teghra, Dist.-Begusarai who are in custody since 18.01.2026 and also heard learned Addl. P.P. for the State on the bail petition dated 07.02.2026 in connection with Teghra P.S. Case No. 441 of 2025, registered u/s-126(2), 115(2), 109/3(5) of BNS pending in the Court of Id. CJM, Begusarai.

The prosecution story in brief is that the informant's husband is a rickshaw puller and on 22.12.2025 at about 09:30 p.m he was coming back to his home near Teghra Bhagirathi Road Goriyari then Raj Kumar Choudhary @ Latto(petitioner) stopped him and on the point of Hansuli, demanded money. When informant's husband made objection then Raj Kumar Choudhary (petitioner) and Mahendra Choudhary(petitioner) along with two unknown persons assaulted upon his neck, back, Panjara, nose and leg by Lathi-Danda and butt of Hansuli with intention to kill due to which bone of Panjara fractured. After badly beating, they threw him by the roadside in unconscious and covered in blood condition. So this case.

The learned counsel on behalf of the petitioners has submitted that no any B.A or ABA has been filed before this court or before the Hon'ble High Court, Patna. There is one criminal antecedent against the petitioners vide Teghra P.S Case No. 69/2025, u/s-126(2), 115(2), 303(2), 352/3(5) of BNS. The petitioners are quite innocent and they have no committed offence. The petitioners have been falsely implicated in this case. There is no offence u/s-109 of BNS against the petitioners. The petitioners are in judicial custody since 18.01.2026. So considering these facts the petitioners may be enlarged on bail.

On the other hand, the Addl Spl. PP for State has vehemently opposed the prayer of bail to the accused/petitioners.

Having heard both the parties and perused the case record as well as case diary. On perusal of record, it appears that the petitioners are named accused in Teghra P.S. Case No. 441 of 2025, registered u/s-126(2), 115(2), 109/3(5) of BNS. Further, it appears that the petitioners

are not only named in the FIR, but there is also direct and specific allegation of assault upon the informant's husband with Lathi-Danda and butt of Hansuli with intention to kill. On perusal of injury report it appears that three injuries as 1. Diffuse swelling of size 3 c.m x 2cm on left eye, 2. Diffuse swelling of size 2 cm x 2 cm and 3. Diffuse swelling of size 6 cm x 5 cm over right side of chest and out of which two injuries are grievous in nature which are vital part of body. On perusal of case diary it also appears that the re-statement of informant at para 2 and the statements of witnesses at para 6, 7 & 8 of case diary have fully supported the case of prosecution. Further at para 11 of case diary; the statement of injured it appears that he has also supported the case of prosecution. After finding the case true against the petitioners, the charge-sheet has been submitted.

Considering the above facts and circumstance and the seriousness of the offence and further taking into consideration the matter; this Court is of the view that accused/petitioners do not deserve bail. Accordingly, his prayer for bail is **rejected**.
