CHARGES WITH SIX HEADS

I, Brajesh Kumar Singh, District & Additional Sessions Judge-II-cum-Special Judge MP/MLA, Begusarai, on 15.04.2026, charge you, the accused persons, namely i. **Mukesh Soni** and ii. **Poonam Devi** as follows:-

Firstly- That both of you along with others on 05th day of October, 2025 at 08.10 P.M, at Village Tetri, Informant's House, P.S. Dandari, District-Begusarai in furtherance of common intention, voluntarily caused hurt to Sailesh Soni and thereby committed an offence punishable u/s 115(2), r/w 3(5) of B.N.S. and within my cognizance of the Court.

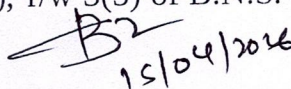
Secondly- That both of you along with others, on or about the same day, same time and same place in furtherance of common intention, wrongfully restrained Sailesh Soni and thereby committed an offence punishable u/s 126(2), r/w 3(5) of B.N.S. and within my cognizance of the Court.

Thirdly- That both of you along with others, on or about the same day, same time and same place in furtherance of common intention, voluntarily caused to hurt to Sailesh Soni, which used as a weapon firearm of offence is likely to cause death and thereby committed an offence punishable u/s 118(1), r/w 3(5) of B.N.S. and within my cognizance of the Court.

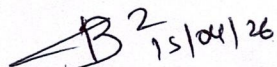
Fourthly- That both of you along with others, on or about the same day, same time and same place in furtherance of common intention, voluntarily caused grievous hurt to Sailesh Soni, and thereby committed an offence punishable u/s 117(2), r/w 3(5) of B.N.S. and within my cognizance of the Court.

Fifthly- That both of you along with others, after marriage of Priyanaka Kumari in furtherance of common intention, criminal trespass by entering into the house of Sailesh Soni, and thereby committed an offence punishable u/s 329(3), r/w 3(5) of B.N.S. and within my cognizance of the Court.

Sixthly- That both of you along with others, after marriage of Priyanaka Kumari in furtherance of common intention, voluntarily caused grievous hurt by means of any instrument for shooting to Sailesh Soni from acid and thereby committed an offence punishable u/s- 124(1), r/w 3(5) of B.N.S. and within my cognizance of the Court.
