1. Today, the case is fixed for leading D.E.
2. Today, on behalf of the accused persons, an application seeking:-
 - (a) **for marking exhibits of the C.C. of FIR and charge-sheet in Dandari P.S. Case No-132/2025**- In the application, the certified copy of the FIR and charge-sheet are attached. Since, the FIR and charge-sheet are relevant documents, they are allowed to be exhibited as Ext.A-1 and Ext.A-2 respectively.
 - (b) **Prayer to summon OPD register**:- In the above-said application, the prayer is also made to requisition the OPD register from P.H.C., Dandari. In the application, it is not stated as to the OPD register of which date is to be requisitioned. It appears that the entire OPD register of Dandari P.H.C has been requested to be called. It is clarified that entire OPD register of Dandari P.H.C can not be called. Court can not be burdened to bring the voluminous and unrelated documents on behalf of the parties. It is up to the party to bring his/her evidence before the court. Hence, the request of the accused to summon entire OPD register of Dandari P.H.C. is hereby **REJECTED**. However, Ld. Senior counsel for the accused has clarified that since the accused was admitted in PHC Dandari on 05.10.2025 at PHC Dandari, therefore, let OPD register of 05.10.2025 be summoned from the PHC Dandari. The submission of Ld. Senior counsel appear to be reasonable, hence, let the requisitioned be sent from the court seeking the OPD register of 05.10.2025. O/C is directed to send the requisition to PHC Dandari for getting OPD register of 05.10.2025.
 - (c) **Request to summon the injury report**:- In the above-said application, the accused has also requested to summon the injury report from the court of Ld. Jai Prakash Mahto, in Dandari P.S. Case No-132/2025. In this regard, let the entire the record of Dandari P.S. Case No-132/2025 be summoned from the court of Ld. Jai Prakash Mahto, in Dandari P.S. Case No-132/2025. Let the requisition be made by O/C in this regard.
In view of above observations, the application filed on behalf of the accused is hereby **ALLOWED**.
3. Ld. senior counsel has submitted that, on behalf of the accused, no other defence evidence is required to be led. However in the interest of justice, let this case be fixed on 30.06.2026 for D.E as the final opportunity for the accused persons to lead any other evidence, if the accused persons so desire. Thereafter, the case would be fixed for arguments. Let the certified copies of all the relevant records be given to the Ld. Counsel for the accused.
