Ram Pukar Mahto vs State of Bihar

**18.03.2026** – This instant criminal miscellaneous has been filed on behalf of the petitioner, **Ram Pukar Mahto**, arising out of A.B.A. No. 2615/2025 in connection with Begusarai Town P.S. Case No. 156/2020.

The Ld. Counsel for the petitioner submitted that the petitioner has been granted anticipatory bail by the order, dated 06.01.2026, of this court vide A.B.A. No. 2615/2025, and the Hon'ble court was pleased to direct the petitioner to surrender/ before the Id. Court below within forty days from the date of order. That after obtaining the order from the Hon'ble High Court, the petitioner went to deposit his installment in electricity department, but the department went against the order and written it's own consent letter or an application and delayed. That the petitioner has written an application for depositing his installment as per the Hon'ble Court order on 08.01.2026, but the department endorse the application on 20.01.2026 after words the electricity board would make the applicant run around many times and send him back making some excuse or the others lastly on 17.02.2026, the petitioner got success to deposit his first installment. That the delay is neither intentional nor deliberate but due to bond fide reasons. That unless the time is extended, the petitioner shall suffer irreparable loss and prejudice. Therefore, it has been prayed to grant reasonable time to the petitioner for surrender in compliance to the order, dated 06.01.2026, passed in A.B.A. No. 2615/2025.

The Learned A.P.P. has not opposed the prayer.
