The record is put up on the strength of put up petititon.

Accused persons are present by filing hazira.

Ld. APP is present and Ld. Counsel is also present along with fresh vakalatnama.

The case is taken up for framing of charge since accused are present.

Heard the Ld. Lawyer for the accused persons and the Ld. APP on the point of consideration of charge.

On perusal of the materials available before me, I find sufficient materials to frame charges against the accused persons under section **341/323/325/506/34 of IPC.**

The contents of the charges have been read over and explained to the accused persons and asked 'are you pleading guilty or not'.

On hearing the accusation, the accused persons pleaded "not guilty" and said in Bengali "Ami Nirdosh" individually and claimed to be tried.

Later:

The complainant and one other witness of this case are present before this Court. As the witnesses are present today along with copy of Aadhar Card, this Court is of the considered view to examine them. so as to ensure speedy trial of this case. They are being identified by their Ld. Advocate.

Complainant namely Santu Ghosh is examined as PW1 of this case in full and thereafter discharged. Through his evidence the signature of the complainant on the complaint is marked as exhibit P-1. Witness namely Asit Ghosh is examined as PW2 of this case in full and thereafter discharged.

Ld. State Counsel as well as Ld. Counsel for the Defence pray for closing of prosecution evidence at this stage.

Hence, the evidence by the prosecution hereby stands closed.

Later.

Accused persons are examined u/s. 313 Cr.P.C and their examination as reduced into writing in separate sheet be kept with the record.

No DW is proposed to be given.

Hence, DW is hereby closed.

The case is taken up for hearing argument.

Heard both sides.

Let the case put up at 02:30 p.m for delivery of judgment.

Later:

It is 02:30 p.m.

Both sides are present.

Accused are present before the Court.

The Judgment to be delivered in the open Court by pronouncing the operative portion of the judgment which is as under :-

ORDERED

That the accused persons namely Asim Ghosh, Sudip Ghosh, Ganesh Ghosh, Kartick Ghosh, Debasis Ghosh, Banobihari Ghosh are found "Not Guilty" for the commission of the offences under sections 341/323/506/354/34 Indian Penal Code and are thus ACQUITTED from this case as per section 248 (1) Code of Criminal Procedure and are set at liberty at once.

The accused persons as well their sureties are hereby discharged from their respective bail bond liabilities.

The seized articles if any on zimma to be permanent after the statutory period is over.

Copy of the Judgment be sent to the District Magistrate, Purba Bardhaman as well as Ld. Secretary, District Legal Service Authority, Purba Bardhaman so as to intimate the Victim/complainant about his/her right to appeal as well as to apprise his/her that he/she can seek legal assistance if he/she so desires through District Legal Service Authority, Purba Bardhaman.

The case is disposed of on contest.
