1. An anticipatory bail petition dated 30-03-2026 has been filed on behalf of accused/petitioners namely; 1. **Chhotan Kumar @ Manish Kumar** s/o-Jwala Rai and 2. **Shrikant Rai @ Shrikant Kumar** s/o-Madan Rai both R/o-Rani Tol, Ward No.11, Dadupur, P.S-Bachhwara, Dist.-Begusarai who are apprehending their arrests in connection with Bachhwara P.S Case No.455/2025 for committing an offence u/s-115(2), 126(2), 75, 303(2), 74, 351(2), 351(3), 119(1), 3(5) of BNS.

2. The prosecution case, in brief, is that on 22.12.2025 at about 06:30 p.m. Shrikant Rai (petitioner), Jwala Rai, Anju Devi, Usha Devi, Chhotan Kumar (petitioner) armed with lathi, danda and pistol entered into the house of informant. Jwala Rai pointed pistol upon informant and Shrikant Rai caught him threw down on bed with bad intention and Chhotan Kumar doing badly behaves with her daughter. Then her younger son went to outside and doing hulla. On halla her husband, Bhaisur and Sasur run away, then Shrikant Rai leave the informant and assaulted with lathi on the nose of her husband. Anju Devi snatched her gold Mangal Sutra from her neck. Usha Devi also snatched a gold locket. Thereafter, they fled away by threatening to kill if you will complain anyone. So this case.

3. The Ld. Counsel appearing on behalf of accused/petitioners submitted that no any B.A or ABA has been filed before this Court or before the Hon'ble High Court, Patna. It is further submitted that the petitioners are innocent, have committed no offence, and they have been falsely implicated in this case. The petitioners have no concern with the alleged prosecution. All sections are bailable in nature except sections 75, 74, 303 of BNS which are not made out against the petitioners. There is no criminal antecedent of the petitioners. He further submitted that petitioners is ready to abide all the conditions imposed by the court, so petitioners may be released on bail.

4. On the other hand, the Addl Spl. PP for State as well as learned counsel for the informant has opposed the prayer for bail to the petitioner.

5. Having heard both the parties and perused the case record along with case diary. On perusal of record, it appears that petitioners are named accused in FIR and there is allegation against the petitioners that they along with other co-accused persons have entered into the house of informant and tried to misbehave with her. On hulla, her husband and others came to save then, they have assaulted upon the

informant's husband with lathi and other co-accused persons snatched gold mangalsutra and ornaments. They have also threatened to kill the family. From perusal of injury report of the injured it shows that "Swelling on left side of forehead" caused by blunt weapon, "Scalp contusion overlying the posterior parietal region" which corroborates the assault by lathi as alleged. The allegation involves house trespass with deadly weapons, attempt to outrage modesty of women, sexual assault, causing hurt by dangerous weapon and loot. On perusal of case diary it shows that the witnesses have supported the prosecution version. The petitioners are named accused in FIR, registered offence u/s-115(2), 126(2), 75, 303(2), 74, 351(2), 351(3), 119(1), 3(5) of BNS. The investigation is still going on.

6. Considering the seriousness and nature of the allegations; I do not find it appropriate to grant the privilege of anticipatory bail to the petitioners. Accordingly, the prayer for anticipatory bail of the petitioners namely, Chhotan Kumar @ Manish Kumar and Shrikant Rai @ Shrikant Kumar is hereby **rejected**.
