ORDER

01.06.2026

1) The pre-arrest bail application under section 482 of Bharat Nagrik Suraksha Sanhita ("BNSS") on behalf of the accused-petitioner-**Vishal Kumar @ Vishal Mukhiya** has been preferred inasmuch as he has been apprehending his arrest in connection with Bhagwanpur P.S Case No- 316/2025, registered for the offences punishable under sections 191(2), 191(3), 190, 126(2), 115(2), 117(2), 118(2), 109(1), 132, 121(1), 121(2), 125(a), 125(b), 221, 192, 61(2), 263, 324(4) of the Bharatiya Nyay Sanhita, 2023 ("B.N.S"), and 27 of the Arms Act, 1959, pending in the court of Ld. C.J.M, Begusarai.

2) The prosecution story is based on the self-statement of S.I Naula Pocket Md. Akram (informant) that on 24.10.2025 at around 05:00 PM, he received information that liquor was being sold openly near Bhith bridge. As per this informant, he reached to the spot, and saw two (2) boys selling liquor like liquid in glasses, seeing the police, the accused persons threw the liquor-cane in the river. As per informant, one of the accused was apprehended who disclosed his name as Rohit Kumar, while the other accused fled away, thereafter, the police seized the motorcycle from them, and while the motorcycle and the accused were being taken to the police station, in the meantime, the accused Rohit's mother-Kala Devi intercepted the police, while his sister-Jyoti Kumari assaulted Chaukidar-Ravindra Kumar with a lathi. As per informant, thereafter, the accused's mother-Kala Devi with several others started pelting stones at the police force, and both ladies managed to rescue the arrested accused-Rohit Kumar from the clutches of police. As per informant, the accused was again apprehended, and while he was being taken to the police station, and in the way to the police station, Kala Devi her sons under leadership of Ramprit Yadav had obstructed the road near Hanuman Mandir, Sanjat road. When the informant reached there along with his police force, the mob started pelting stones at them, due to which several police personnel sustained injuries. Lastly, the

police opened the fire, and then mob was controlled. The matter was video-graphed, on the basis of video footage, several persons were identified.
