Heard learned Counsel on the Anticipatory bail application filed on behalf of the petitioner namely Dhiraj Kumar, S/o Ganesh Singh, aged about 45 years, who has apprehension of arrest in connection with Refinery, P.S., Case, No.-32/2026, U/s- 135 of Electricity Act, pending in the court of C.J.M./Concerned Court, Begusarai. Also heard the learned Addl. P.P. for the State. 2. It has been submitted on behalf of the petitioner that this accused petitioner is quite innocent and has committed not any offence as alleged in the aforesaid case. This accused petitioner never file any type of bail petition under any provision of law before this learned court or Hon'ble High Court, Patna. No any criminal antecedent is pending before any court of law or any police station. This accused petitioner has been falsely implicated in this case at the instance of his enemy under conspiracy and high handedness of the Electricity department. 3. Learned APP strongly objected the Anticipatory bail application and submitted that the allegation against the petitioner is very serious. So, he requested to reject the anticipatory bail application. 4. The prosecution story in brief is that on 26.03.2026 Keshav Kumar J.E. Electricity Supply Department, Tiltrath under chief Engineer for theft of Electricity one raiding scott with five other official organized and raid on scret information before one accused Raju Kumar and other this petitioner Dhiraj Kumar on 26.03.2026, at 11:12 A.M within residential campus and got without legal connection, connected with service wire in his commerical campus and was using electricity for energy when as this electricity weight was 1.943 Kilo Watt under Tarif NDS 1D was present. After same his wire had been disconnected and same wire seized by the raiding Party whose seizers is attached with same from this activity North Bihar Power Distribution Company Ltd. Imposed loss of Rs. 248685/- (Two Lakh forty eight thousand six hundred and eighty five rupees with fourteen paisa) with is ultimately loss of revenue of same which should be collected from this petitioner after asking he fail to produce any legal document related to same electricity connection, hence can had been filed U/s- 135 Electricity Act against the same person i.e. petitioner Dhiraj Kumar.

Contd. 13.07.2026	5. Heard both the sides and perused the record. Upon consideration of the submissions made on behalf of the petitioner and the materials available on record, it appears that the allegation against the petitioner is of unauthorized use of electricity under Section 135 of the Electricity Act. The prosecution case is based on a raid conducted by the officials of the Electricity Supply Department, wherein it is alleged that the petitioner was found using electricity without a legal connection in his commercial premises. Considering the facts and circumstances of the case, I find it proper to give the benefit of anticipatory bail to the petitioner and order that the <i>petitioner shall deposit Rs. 40,000/- as the first installment, and the receipt of the same shall be produced at the time of furnishing bail bond and the remaining amount of Rs. 2,08,685/- shall be deposited in seven E.M.I., each installment of Rs. 29,812/- must be deposited between the 1st to 10th day of every month and after the deposit of last installment the bail shall be confirmed.</i> Accordingly, the Ld. Court below is directed to release the petitioner, on arrest or surrender before the court below within one month from the communication of this order. He shall be released on furnishing bail bond of Rs. 10,000/- each with two sureties of the like amount each to the satisfaction of the Ld. Court below. (Dict.) Sd/- I/C Dist. & Addl.
