It appears that inspite of issuance of processes of warrant and process of S. 82 and S. 83 of Cr.P.C. the accused has not appeared till date to face trial.

The service report and execution report are not available with record as no one is ready to comply the order of the court.

The accused persons have not appeared since 18-04-2007 But, for how long court should wait for the appearance of the accused persons. The court waited for a long approx 18 years. The record is unnecessarily being posted without any progress. Entire exercise becomes futile. The conscience of the court is not convinced that accused have no knowledge of the pendency of the case against them. The accused appears to have fled from justice by avoiding their arrest or they might have been audacious enough to play hide and seek with justice. Accused appears to be bold enough.

Taking into consideration the aforesaid facts this court does have two option either to wait for appearance of the accused persons for indefinite period or declare them absconder. The second

Uday Mishra, S/o Suresh Mishra, R/o vill.- Gokhle Nagar, Vishnupur, P.S.-Ballia, Distt.-Begusarai and 3. Murari Singh S/o Pramod Singh, R/o vill.- Gokhle Nagar, Vishnupur, P.S.-Ballia, Distt.-Begusarai are declared **absconder**.

Issue **permanent warrant** against the accused persons.
Submit the record to record room to be produced when either accused persons surrender or arrested. Mention the disposed in decided register.
