ORDER

An anticipatory bail petition has been filed on behalf of above named accused/petitioner who is apprehending his arrest in connection with above mentioned case for committing of the offences u/s-457, 380 of I.P.C and the same has been put up for hearing.

Heard Learned Counsel Sri Ramratan Das, appearing on behalf of accused/petitioner, and Learned P.P. I/C for the State.

Prosecution case, in short, is that on 14.10.2021 in the evening informant Dr. Sarita Kumari proceeded for out side from house, when she returned on 15.10.21 in the night at about 2.15 A.M she saw the lock of the house open and the articles kept in Almirah are scattered. Mangal Sutra of gold 40 gram, Jhumka of gold 37 gram, small chain of gold 20 gram, top of gold 12 gram, Small top of gold 5 gram Payal 3 pair 80 gram golden coin 30 gram, cash 7000/- were missing. She immediately informed the police.

The learned counsel appearing on behalf of the accused/petitioner submitted that the petitioner has not previously filed any application for bail, whether anticipatory or regular, before this Court or any higher court. It was further submitted that the petitioner is innocent, has committed no offence, and has been falsely implicated in the present case. The petitioner not named in F.I.R his name came in the confessional statement of other accused in para no.27 of case diary. No incriminating article has been recovered from the possession of the petitioner and house of the petitioner. No case of u/s 457, 380 of I.P.C is made out against the petitioner. The petitioner has one criminal antecedent, he is ready and willing to comply with all conditions that may be imposed by this Court, and therefore, he deserves to be released on bail.

Per contra, the learned P.P. I/C appearing on behalf of the State vehemently opposed the prayer for bail.

Heard the learned counsels for the parties, and perused the L.C.R including case diary. As per F.I.R, the petitioner is not named in F.I.R and his name has been surfaced out on the basis of confessional statement of co-accused Shivjee Kumar in

Para 32 of case diary. However, at present, there is no substantive material on record against this petitioner, except for confessional statement of other co-accused. The petitioner was not apprehended on the spot. No incriminating article has been recovered from the conscious possession of the petitioner. Furthermore, co-accused, namely Santosh Kumar and Shivjee Kumar, Nepali Sah have been already granted bail by this court vide order dated 12.01.2022, 29.01.2022 & 12.06.2026 passed in B.A. No. 1651/2021, B.A. No. 1629/2021 & B.A No.788/2026.

Considering the aforesaid facts and circumstances, the petitioner is directed to be released on bail in the event of his arrest or surrender before the learned court below within one month from the date of this order, on furnishing a bail bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of the like amount each, to the satisfaction of the learned court below, in connection with Town P.S. Case No. 625/2021, subject to the following conditions:

1. The petitioner will make himself available for interrogation by a police officer/court as and when required.
2. The petitioner shall not directly or indirectly make any inducement, threat, promise to any person acquainted with the facts of the case as to dissuade them from disclosing of such fact to the court or any police officer.
