CHARGES WITH EIGHT HEADS

I, Brajesh Kumar Singh, District & Additional Sessions Judge-II-cum-Special Judge MP/MLA, Begusarai, on 21.04.2026, charge you, the accused persons, namely i. **Subhash Singh**, ii. **Ram Pukar Chaurasia**, iii. **Ram Charitra Singh**, iv. **Rajendra Singh**, v. **Pappu Yadav**, vi. **Ram Naresh Singh**, vii. **Vivekanand Singh**, viii. **Shivam Kumar @ Shiv Jha**, ix. **Md. Murtuza** as follows:-

Firstly- That all of you along with others, on 06th day of June, 2007 at about 06.10 A.M. at Barauni Fhalaig Station, P.S. Barauni, District-Begusarai in furtherance of common intention, were armed with deadly weapon were member of an unlawful assembly, and thereby committed an offence punishable u/s 144 of I.P.C and within my cognizance of this court.

Secondly- That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, assaulted to Police persons, a public servant in the execution of his duty as such public servant and thereby committed an offence punishable u/s 353 of I.P.C and within my cognizance of this court.

Thirdly- That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object committed mischief by causing wrongful loss or damage to Govt. property (Train, Station etc.) and thereby committed an offence punishable u/s 427 of I.P.C and within my cognizance of this court.

Fourthly- That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object willfully obstruct Railway track from obstructing a railway servant in their duties and thereby committed an offence punishable u/s 146 of Indian Railway Act and within my cognizance of this court.

Fifthly - That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object did an act to block the railway track with cement bench and thereby committed an offence punishable u/s 150 of Indian Railway Act and within my cognizance of this court.

Sixthly- That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object with intent to cause damage and destructed Railway properties like Train Haas pipe etc. by fire breaking them likely to endanger the operation of railway property and thereby committed an offence punishable u/s 151 of Indian Railway Act and within my cognizance of this court.

Seventhly- That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object criminalizes endangering the safety of railway passengers or obstructing rolling stock through unlawful acts or willfully neglect and thereby committed an offence punishable u/s 153 of Indian Railway Act and within my cognizance of this court.

Eighthly - That all of you along with others, on or about the same day, same time and same place in furtherance of common intention, common object penalizes individuals who obstruct or attempt to obstruct the running of trains and thereby committed an offence punishable u/s 174 of Indian Railway Act and within my cognizance of this court.
