The accused **Lovkesh, Abhi, Rinku son of Ramesh, Bagga alias Pagga, Jagga, Samson, Ravi Pardhan, Rishu son of Ramesh and Rinku son of Mahinder Pal** were summoned through proclamation under section 82 Cr.P.C vide order dated 27.09.2022. Summoning official came present on 04.10.2022 and he got recorded his statement that he had affixed the proclamations of accused **Lovkesh, Abhi, Rinku son of Ramesh, Bagga alias Pagga, Jagga, Samson, Ravi Pardhan, Rishu son of Ramesh and Rinku son of Mahinder Pal** on 30.09.2022. That proclamations are Ex.PA, Ex.PC, Ex.PE, Ex.PG, Ex.P1, Ex.PK, Ex.PM, Ex.PO and Ex.PQ and reports are Ex.PB, Ex.PD, Ex.PF, Ex.PH, Ex.PJ, Ex.PL, Ex.PN, Ex.PP and Ex.PR and the accused were to appear today. Today, none has appeared on behalf of the accused. I am satisfied from the statement of SI Gurbax Singh and proclamation of accused (1) Lovkesh son of Major resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur, (2) Abi son of Mahinderpal resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (3) Rinku son of Ramesh resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (4) Bagga alia Pagga son of Unknown resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (5) Jagga son of Seera, resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (6) Samson son of Rinku, resident of Shanti Nagar, Ferozepur (7) Ravi Pardhan son of unknown resident of Shanti Nagar, Ferozepur (8) Rishu son of Ramesh resident of Shanti Nagar, Ferozepur (9) Rinku son of Mahinder Pal resident of village Naurang

Ke Leli Wala, Tehsil and District Ferozepur are duly effected under section 82 Cr.P.C. They have failed to appear within 30 days of the proclamation. As such, accused (1) Lovkesh son of Major resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur, (2) Abi son of Mahinderpal resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (3) Rinku son of Ramesh resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (4) Bagga alia Pagga son of Unknown resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (5) Jagga son of Seera, resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur (6) Samson son of Rinku, resident of Shanti Nagar, Ferozepur (7) Ravi Pardhan son of unknown resident of Shanti Nagar, Ferozepur (8) Rishu son of Ramesh resident of Shanti Nagar, Ferozepur (9) Rinku son of Mahinder Pal resident of village Naurang Ke Leli Wala, Tehsil and District Ferozepur are declared as proclaimed persons. Intimation of the proclamation be sent to the SHO. SHO was directed to submit the property of the above said accused persons under section 83 Cr.P.C but no property is submitted. SHO is further directed to submit the list of property. He may move separate application for attachment under section 83 of Cr.P.C. Accused Lovepreet Sandhu and David have not produced by the jail authorities. Let production warrants of the accused Lovepreet Sandu and David be issued for 16.11.2022.
