JUDGEMENT
(No Evidence)

1. The above named accused persons stand charged and facing trial for committing the offences punishable U/Ss.-**394/120(B) of IPC.**
2. The cognizance of offences punishable **U/Ss.- 394/120(B) of IPC.** was taken against above named accused persons vide order dated 28.03.1995. After securing the appearance of the accused persons the police papers were served on to them on 06.09.2024 in compliance of section 207 of CrPC and on the same day the Charge of offences punishable **U/Ss.- 394/120(B) of IPC** were framed and explained to the accused person to which he pleaded not guilty and claimed to be tried. Thereafter, the case record was fixed for prosecution Evidence. At this stage no any witness was produced on behalf of the prosecution. No documentary evidence or material object was put on record on behalf of the prosecution. Hence the prosecution Evidence was closed vide order dt.-18.03.2026. The

accused persons maintained their defence of being innocent in their statement u/s-313 of CrPC.

FINDINGS

3. Considering the lack of any evidence it is evident that the prosecution has failed to prove its case and the argument advanced by the learned defence counsel gains weight. Considering the facts, circumstances, evidences and material available on case record and after hearing the learned counsel for defence and learned S.D.P.O for prosecution, this Court finds and holds that prosecution has failed to prove charges levelled against accused. Hence, this court is of opinion that in this case the accused persons are entitled for acquittal from charges levelled against them.

ORDER

4. In the result, it is ordered that-

“the accused person namely **1.Ajay Sahni**, is found and held **not guilty of the offences punishable U/Ss.- 394/120(B) of IPC**. Accordingly, above named accused person is hereby **acquitted of aforesaid punishable offences**. **They are set at liberty**.

Since, he is on bail, his **bailors are also discharged from the liabilities of their respective bail bonds.**”
