Orders of Hon'ble Punjab and Haryana High Court passed in CRM-M-1070 of 2024 received as per orders of Hon'ble Punjab and Haryana High Court, the said FIR has been quashed against the accused. Therefore nothing remains to proceed in this case. In view of the said order of Hon'ble Punjab and Haryana High Court, all the accused are discharged. Sureties and surety bonds of accused stands discharged.

Also an application has been filed by the applicant Balbir Kaur/accused, stating that during investigation of this case, the police of PS Talwandi Chaudharian has recovered some articles i.e. 12 stitched lady suit, one gold set consisting of one necklace, two gold ear topas and one gold lady ring from accused Balbir Kaur vide recovery memo. That complainant Harwinder Kaur and her parents have no concern with the said articles as they exclusively belong to Balbir Kaur that the matter has been compromised in the supervision of Hon'ble High Court and the petition for divorce with mutual consent is also pending before the Family Court, whereby it has been recorded that Harwinder Kaur and her parents have no concern with the recovered articles and they are exclusive

property of Balbir Kaur. Further prayed that directions be issued to IO concerned to return the above said articles recovered from Balbir Kaur.

Arguments heard, record perused i.e. petition under Section 13-B of Hindu Marriage Act whereby it has been mentioned that the complainant has no objection if the said articles are being released to the accused Balbir Kaur. To further fortify such facts Harwinder Kaur has suffered her statement before the Court stating that she does not want those articles as they does not belong to her and she has no objection if the said articles are handed over to Balbir Kaur as per the compromise.

Therefore, in view of the contents of the application, declaration of the complainant and quashing of the present FIR I deem appropriate to issue directions to the IO concerned of the present FIR to release the articles as mentioned in the application, in favour of applicant Balbir Kaur. Application be attached with the main file. File be consigned to the Record Room, Sultanpur Lodhi.
