Complainant Jeera Devi files this case against seven persons named in the complaint petition regarding the offence of cruelty, assault and others. Firstly, the complainant was examined on S.A. and thereafter inquiry witnesses namely, EW1 Ranjeet Tanti and EW2 Chhotan Shah have been examined on behalf of the complainant.</p> <p>2. Perused the Complaint petition, solemn affirmation of the complainant, statement of the witnesses recorded during inquiry under Section 223(1) of the Bhartiya Nagarik Suraksha Sanhita 2023, and the material available on record. It appears from the complaint that the accused namely, Sahdev Shah, deceitfully married the complainant eighteen years ago by concealing his earlier subsisting marriage and existing wife and children. After marriage, the complainant was subjected to cruelty, abuse and physical assault. It is further alleged that the accused persons demanded a sum of Rs. 3,00,000/- as dowry and on non-fulfilment of such demand, accused persons subjected the complainant to harassment and ultimately drove her out from her matrimonial home. Allegations also disclose that accused Sandeep Kumar took Rs. 20,000/- from the complainant and refused to return the same.</p> <p>3. Subsequent to the closure of inquiry, notice was issued to the proposed accused persons as mandated under Section 223(1) of BNSS, out of whom four accused persons namely (1) Md. Alam, (2) Sanjay Paswan (3) Mukesh Kumar and (4) Karan Kumar appeared, while other did not appeared. Upon such inquiry, this Court is satisfied that</p> | ,                             |

sufficient ground for proceeding exists against the accused persons. At this stage, a meticulous appreciation of evidence is neither required nor permissible.

4. As such, considering every aspects of this case it appears that there is sufficient ground to proceed further in this case. As such, a prima facie case is made out u/s- 85 of B.N.S. and against the accused persons namely, 1. Sahdev Sah, 2. Md. Alam and 3. Sanjay Paswan. The tendency to rope all the members of the family of the husband in such cases requires to be thwarted. Complainant is directed to file requisites for issuance of summons within 7 days against accused persons, thereafter o/c shall issue summons just after receiving of requisites.
