**JUDGMENT**

1. *Ranjit Mahto, S/o- Upendra Mahto, The resident of village-Barauni 02 Madhurapur, Police Station-Teghra, District- Begusarai, 2. Chandani Devi, D/o- Rajeev mahto, The resident of village- Maniyapa, Police Station-Matihani, District-Begusarai.* The above named accused persons stand charged for the offence punishable U/s. 352, 452, 341, 323, 504 & 34 of the I.P.C. to which they pleaded not guilty and claimed to be tried.
2. **The Factual Matrix of the case are as follows:** The written complaint of the informant namely, *Tuna devi* that today, on 12.01.2007 Friday, 12 P.M. I was sitting near my house when *Baby Devi* wife of *Rajo Mahato*, who is our neighbor came and started abusing. Meanwhile, *Rajo's* sister-in-law *Nikki Devi* and *Rajo's* niece *Chandni Devi* came with sticks in their hands and they also started fighting . Meanwhile, *Babita Devi* , wife of *Gopal Mahato, Rajo's* mother-in-law, name unknown, and *Ranjit Mahato, father Upendra Mahato @ Opi Mahato* all residents of *Barauni-2, Police Station-Teghra, District- Begusarai,* came and they also started abusing. After this, *Ranjit Mahato* said that all of you should beat us together. On hearing this, all the people mentioned above started beating us together. In which *Rajo's* sister-in-law *Chandni Devi* hit our daughter-in-law *Hira Mani Devi, wife of Devendra Mahato,* with a stick, due to which the wrist of the right hand got injured sand also on the head. After this, the villagers came and rescued me and my daughter-in-law became unconscious. After this, I went to the *Mukhiya ji,* then the *Mukhiya ji* sent me to the police Station. Then I came to the Police station and met the Inspector with my son *Devendra.* He has submitted a written statement to his brothe-in-law, *Lalo Mahato, father of the late Kailash Mahato, of Barauni 3, Police Station Teghra.* This dispute is over land near his house.
3. On the basis of written report of informant the police registered the case as *Teghra P.S.* case no. 06/2007 dated 12/01/2007 and investigation was taken up. After conclusion of investigation police submitted charge sheet against the said accused person vide charge sheet no. 201/2007 dated 26/08/2007, U/s- 452, 354, 352, 341, 323, 504 & 34 of I.P.C. and the Ld. C.J.M. *Begusarai* took cognizance of the offence under same sections on dated 27.11.2007 and charges against accused persons were framed U/s. 352, 452, 341, 323, 504 & 34 of the I.P.C. by Ld. J.M.F.C. *Teghra* on 11.12.2018.

4. The prosecution has failed to adduce witness against the accused persons.
5. The case of the defence is general denial of whole of the prosecution case and the accused persons have taken the plea of innocence at the time of recording of their statement u/s- 313 Cr.PC. The defence did not adduce any evidence.
6. Now the question for determination arises before this Court is whether the prosecution has been able to prove its case beyond the shadow of all reasonable doubts.
