The defence Counsel has submitted that the petitioner is quite innocent and has committed no offence. He was on bail granted by Ld. Hon'ble High Court of Patna. No any bail petition has been filed in any higher court. Due to lack of knowledge of the specific order of the Ld. court pairvikar could not inform the petitioner and his bail-bond has been cancelled on 07/06/2023. He was arrested by the police on 07-10-2024. They accused petitioner is ready to furnish bail-bond as per directed by your honour. On the submission, ld. Counsel prays to enlarge the accused on bail.</p> <p>Heard, Perused the case record. After perusal of the case record, it transpires that his bail-bond has been cancelled on 07-06-2023. The petitioner is in custody since 07-10-2024. Cognizance has been taken of offences punishable u/s- 414 of the IPC &amp; 25(1-b)a/26/35 of arms act. The accused pleaded not to commit such mistakes in the future.
