05-05-2026	The petitioner namely Krishna Gopal apprehends her arrest in connection with Sultanganj P.S. No 517/25 registered under Sections 126(2), 115(2), 331(5), 109, 351(3), 352, 3(5) BNS. On behalf of the petitioner, a certificate has been given in para 2 of the bail petition that he has not filed any bail petition in any form on previous occasion either in the court of Learned Sessions Judge, Bhagalpur or before the Hon'ble High Court, Patna. The petitioner bears clean antecedent. The prosecution story as stated in the First Information report in brief is that on 06-11-2025, at about 10:00 AM accused persons namely Arvind Kumar Singh, Krishna Gopal, Ranju Kumari, Annapurna Kumari, Swati Kumari @ Swati Bharti, Nidhi Kumari along with 3-4 unknown persons arrived at informant's house. According to informant Akshay Kumar @ Devesh Kumar, Krishna Gopal used a drill machine to break the wall of his house and entered his house. When informant protested, Arvind Kumar Singh ordered to assault him and following on his orders everyone collectively began to beat him. Thereafter, Annapurna Kumari assaulted on right thigh of informant with a danda, due to which he got injured. Thereafter, Krishna Gopal assaulted on informant's forehead with a dabia with the intent to kill him, causing head injury. Krishna Gopal again tried to assault on informant's head with the dabia which he blocked with his left-hand causing injury in his wrist and fingers. Thereafter, Ranju Kumari used abusive language and told Swati to hit, on which she punched in informant's right eye causing it to swell. When informant raised an alarm then some neighbors and his father Anil Kumar Singh arrived there for his rescue. Swati Kumari then threw red chilli powder into his father's eyes and all the accused persons flee away. Thereafter, informant dialed 112 and then police arrived and then he went to the police station and from there he was sent to the Referral Hospital, Sultanganj for treatment and

05-05-2026 Contd.P/2	was subsequently referred to Mayaganj Hospital, Bhagalpur where he is currently undergoing treatment. According to informant, reason behind the incident is that the accused persons want to grab the land belonging to him. The Learned counsel for the petitioner submitted that the petitioner is innocent and has committed no offence and has falsely been implicated in this case with malafide intention of the informant. He further submitted that there is delay of about 10 days in lodging of FIR without any cogent explanation which creates doubt regarding the genuineness of whole prosecution story. He further submitted that this case is nothing, but counter blast of the case filed by one of the co-accused. He further submitted that there is land dispute between the informant and the petitioner. On these grounds, prayer has been made to grant anticipatory bail to the petitioner. The learned Additional Public Prosecutor for the state vehemently opposed the prayer for bail. Heard both sides, perused the case record and case diary. Injury Report of Akhay Kumar @ Akshay Kumar has been mentioned at para 30 of the case diary reveals laceration wound on frontal to parietal region, laceration wound on left hand proximal phalanx, laceration wound on left shoulder, abrasion on right thigh and doctor opined the nature of injury is simple by HBS and weapon used is lathi. At para 51 and 52 of the case diary, the statements of independent witnesses has been mentioned and from perusal whereof it transpires that the main reason for the dispute is division of ancestral land and there is long standing dispute between the parties and the present case is offshoot of pre-existing civil dispute. This case is counter case of Sultanganj P.S 512/2025 which was lodged by the one of the co-accused of this case and the petitioners of Sultanganj P.S 512/2025 have already been granted anticipatory bail vide order dt. 05-01-2026 in ABP2735/2025 and ABP-2736/2025 by the Court of Ld. Additional Sessions Judge-XVI, Bhagalpur. Further, dispute between the parties appears to be mutual in nature and people from both sides were injured in the incident. Other co-accused petitioners have already been granted anticipatory bail vide order dt. 23-02-2026 in ABP 2717/25 by the then predecessor of this Court and vide order dt. 02-05-2026 in ABP 459/26 by this Court. Therefore, considering the facts and circumstances of the case as discussed above, the anticipatory bail application of petitioner is allowed. It is ordered that in the event of arrest or surrender before the learned court below within four weeks from the date of receipt/production of this order, the above-named petitioner shall be released on
