25.05.2026	- The accused persons namely 1. Shyam Yadav @ Shyam Lal Yadav 2. Asha Devi 3. Gunjan Yadav @ Gunjan Kumar 4. Dolly Devi and 5. Manju Devi are physically present before this court. The matter is listed for hearing on framing of charge. - Case called out. The learned defence counsel appeared. The learned Additional Public Prosecutor for State is already present. - Heard both sides on point of framing of charge and perused the case record. Finding sufficient material for framing of charge against the accused persons namely 1. Shyam Yadav @ Shyam Lal Yadav 2. Asha Devi 3. Gunjan Yadav @ Gunjan Kumar 4. Dolly Devi and 5. Manju Devi, charge is framed under Section 147, 341, 504, 506, 354 and 436 of the IPC and Section 3(1)(r)(s) of the SC/ST Act. The contents of charge are read over and explained to the accused persons in hindi, to which they pleaded “not guilty” and claimed trial. - Now that charge has been framed, the prosecution is directed to produce it's evidence forthwith. The prosecution shall produce witnesses on consecutive dates, for which multiple dates will be fixed. - The learned A.P.P. submits that the prosecution intends to examine all the persons named as witnesses in the charge-sheet and hence prays that summons be issued to all the witnesses and, for proper service, atleast 45 days' time be granted. Accordingly, proper time must be allowed to secure service of summons so that witnesses may be produced and examined on consecutive dates. - Heard. Considering the submissions of Ld. A.P.P. proper time for service of summons is allowed. Accordingly, the following calendar is fixed for examination of prosecution witnesses: PW-1 on 07.08.2026 PW-2 on 10.08.2026 PW-3 on 11.08.2026 and so on, on a day-to-day basis until completion.
