| 20-04-2026                  | <p>The petitioner namely <b>Manas Kumar @ Manas Kumar Singh</b> who is in custody since 17-01-2026 has filed this bail petition in connection with <b>Mahila P.S. Case No. 02/2026</b> registered under Sections <b>64, 115(2), 79, 351, 351(2) &amp; (3) of BNS</b>.</p> <p>On behalf of the petitioner a certificate has been given in para 2 of the bail petition that the petitioner has not filed any bail petition in any form on previous occasion either in the court of Learned Sessions Judge, Bhagalpur or before the Hon'ble High Court Patna. Further the petitioner has no criminal antecedent as per para 3 of the bail petition.</p> <p>Prosecution case as per written application of informant-cum-victim in brief is that she got acquainted with Manash Kumar who introduced himself as a constable in the Bihar Police and trapped her in a web of love by proposing marriage. She further stated that in the month of September 2025 the accused petitioner called her to meet at his rented house where he established forced physical relation with her and also recorded a video of it on his phone. Thereafter, accused began blackmailing her over the phone that would make the video viral. On 13-01-2026, Manash Kumar called her from mobile number 9204559661 and asked her to come to Ghantaghar and also threatened to leak the video if she did not come. Terrified, she went to meet him. From Ghantaghar, accused took her to "The Adda Restaurant &amp; Cafe" in Tilkamanjhi. He also threatened to kill her for dire consequences. When informant stated that she would complain to the police accused snatched her phone and physically assaulted her. Thereafter, informant have narrated all these incidents to her parents and hence the present FIR.</p> <p>The Learned counsel for the petitioner submitted that the petitioner is innocent and has committed no offence and has falsely been implicated in this case due to dirty village politics. He further submitted that FIR has been lodged on 17-01-2026 and incident mentioned in the FIR occurred in the month of September 2025 which creates doubt. He further submitted that there is no eye witness of the incident and the victim has not raised alarm at the time of incident. He further submits that petitioner is languishing in judicial custody since 17-01-2026. Para-02 of the case diary is the re-statement of victim-cum-informant. Para 3, 4 and 15 of the case diary are the statements of witnesses who have supported the prosecution case. Para 44 of the case diary is the statement of victim recorded u/s 183 BNSS wherein the victim stated that she had love relation with accused petitioner. From the last six months accused petitioner used to make physical relation with her on the assurance of marriage but later on he denied and also threatened to make her vidoes and photo viral. She further stated that on 10-01-2026 accused had sent her naked photos to her family members and also threatened to throw acid on her. There is direct allegation against this petitioner to make physical relation. From further perusal of injury report of victim it appears that she was 5 weeks one day pregnant on 09-02-2026. Moreover, the DNA Report of victim, accused petitioner and feotus samples have been collected and report of the same is not yet obtained.</p> <p>Keeping in view the nature of the offence, complicity of the petitioner, severity of punishment and submissions of the learned counsel for the parties, and the allegation against the petitioner is serious in nature. So, I am of the view that applicant/petitioner does not deserve for bail.
