No 549/24</b> registered under Sections <b>96, 3(5) BNS</b>.</p> <p>On behalf of the petitioners, a certificate has been given in para 2 of the bail petition that the petitioner has not filed any bail petition in any form on previous occasion either in the court of Learned Sessions Judge, Bhagalpur or before the Hon'ble High Court, Patna. The petitioner bears clean antecedent.</p> <p>The prosecution story in brief on the basis of written application of informant Etwari Das is that on 10-10-2024, at about 10 O'clock, her daughter Manisha Kumar went to college for her admission but did not returned till evening. Thereafter, informant inquired about her daughter from nearby people and relatives, he got to know that one Pramod Kumar had lured her daughter with an intention of marrying her. Rambhol Das and Kiran Devi are also involved in her daughter's abduction. Hence, this FIR.</p> <p>The Learned counsel for the petitioners submitted that they are innocent and have falsely been implicated in this case. He further submitted that there was love affairs in between victim, she was major and she willingly left her house and went along with the petitioner. On these grounds, prayer has been made to grant anticipatory bail to the petitioner.</p> <p>The learned Additional Public Prosecutor for the state opposed the prayer for bail but he conceded the fact that the petitioner is major and she got married with the petitioner with her own will.</p> <p>Heard both sides, perused the case record as well as case diary.</p> <p>From the perusal of record it appears that victim is major. Further informant, victim and petitioner physically appeared before the court and stated that victim and the petitioner had got married with each other.
