22-04-2026	The accused-petitioner Akshay Yadav who is in custody since 07-03-2026 has filed this bail petition in connection with Bhagalpur Mahila P.S. Case No. 12/2024 registered under Sections 376, 420, 323, 504, 506/34 IPC. On behalf of the petitioner a certificate has been given in Para 2 of the bail petition that earlier an ABP 2163/2024 was rejected vide order dt. 27.09.2024. Thereafter, Anticipatory bail of the petitioner was also rejected by Hon'ble High Court, Patna vide Cri. Misc. 26255/2025. Apart from this the petitioner has not filed any bail petition in any form on previous occasion either in the court of Learned Sessions Judge, Bhagalpur or before the Hon'ble High Court, Patna. Further, the petitioner bears no criminal antecedent as per para 3 of bail petition. The prosecution story as per the written application of the informant-cum-victim Nanki Devi, is that she along with her husband lived in Gujarat and did work of labourer and there she met with Akshay Yadav petitioner. Some how he Akshay Yadav her the mobile number and started talking with her. After that, in the year 2022 she along with her husband returned to Bhuvalpur, and Akshay Kumar traced out her address and reached at her home at Bhuvalpur, and Akshay Kumar entered into her room in the absence of her husband and committed rape with her. Akshay Kumar had also recorded her objectionable video and threatened her to make her video viral if she will make noise. After that, Akshay Kumar committed rape with her several times by blackmailing her and Akshay Kumar also started forcing her to establish physical relations with his friend Ranjit Yadav, and when she opposed he threatened to make her objectionable video viral. She further alleged that on 18.12.2023 Akshay Yadav, Pradip Yadav and Ranjit Yadav

22-04-2026 contd...P2	came at her home and started forcing her, and on protest they cut her wrist with knife. She further alleged that on 13.12.2023, informant went to the house of Akshay Kumar where the family of Akshay Kumar namely Sukhdev Yadav and Rajesh Yadav assaulted her and broken her mobile. Thereafter, she informed the police and the police called Akshay Kumar at the police station where Akshay Kumar compromised with her, and after that Akshay Kumar had taken her to Surat from the police Station by making her his wife and in Surat Akshay Kumar used to threat, assault and tried to commit rape with her, so on 06.02.2023 she returned to her home and narrated the entire incident to her husband. Hence, the instant FIR. The learned counsel for the petitioner submitted that the petitioner is innocent and has committed no offence as alleged in the FIR and has falsely been implicated in this case and he is involved in this case just on the basis of suspicion. He further submitted that the petitioner is in custody since 07-03-2026. On the above mentioned ground, it is prayed that the petitioner be enlarged on bail. The Learned Additional Public Prosecutor for the state duly assisted by Ld. Counsel on behalf of informant opposed the prayer for bail. Heard both sides and perused the case record and case diary. Victim in her re-statement mentioned in para-2 of the case dairy have reiterated the prosecution story. Witnesses in para-3, 4 have also supported the prosecution case. Victim in her statement recorded U/s 164 CrPC has stated that she along with her husband lived in Gujarat and did work of labourer and there she met with Akshay Yadav petitioner who some how took her mobile number and started talking with her. After that, in the year 2022 she along with her husband returned to Bhagalpur, and Akshay Kumar traced out her address and reached at her home at Bhagalpur. In the absence of her husband he showing the fear of knife entered into her room, stuffed clothes in her mouth and committed rape with her. He also recorded her objectionable video and threatened her if she will narrate about the same the said video would be made viral, he fled away and thereafter two-three boys namely Pradeep Yadav, Ranjeet Yadav along with petitioner Akshay Yadav and stated that both friends duly satisfied and thereafter Akshay Yadav again committed rape with her and his both friends also tried to force her but but they were unsuccessful. Then they cut her wrist by knife and when she went to petitioner's house. From perusal of case record it

Moreover, there is direct allegation against the petitioner. Having considered the facts and circumstances of the case, nature of allegations made against the petitioner, gravity of offence and the fact that there is direction allegation against this petitioner, this court is of the opinion that the petitioner is not entitled to grant of bail.
