	23.04.2026	1. The sole accused Shivam Kumar is produced from jail custody through Video Conferencing. The matter is listed for hearing on framing of charge. 2. Case called out. The learned defence counsel appeared. The learned Additional Public Prosecutor for State is already present. 3. Heard both sides on point of framing of charge and perused the case record. Finding sufficient material for framing of charge against the accused Shivam Kumar, charge is framed under Section 109, 115(2), 126(2), 351(2)(3)/3(5) of the B.N.S. The contents of charge are read over and explained to the accused in hindi, to which he pleaded “not guilty” and claimed trial. 4. Now that charge has been framed, the prosecution is directed to produce it’s evidence forthwith. The prosecution shall produce witnesses on consecutive dates, for which multiple dates will be fixed. 5. The learned A.P.P. submits that the prosecution intends to examine all the persons named as witnesses in the charge-sheet and hence prays that summons be issued to all the witnesses and, for proper service, atleast 30 days’ time be granted. Accordingly, proper time must be allowed to secure service of summons so that witnesses may be produced and examined on consecutive dates. 6. Heard. Considering the submissions of Ld. A.P.P. proper time for service of summons is allowed. Accordingly, the following calendar is fixed for examination of prosecution witnesses: - PW-1 on 25.05.2026 - PW-2 on 26.05.2026 - PW-3 on 27.05.2026 and so on, on a day-to-day basis until completion. 7. The prosecution shall ensure the presence of witnesses as per the above calendar. The defence shall be ready to cross-examine immediately after examination-in-chief of witnesses. Compliance is mandatory in view of the directions of the Hon’ble Supreme Court in C.B.I. vs. Mir Usman @ Ara @ Mir Usman Ali.
