	<u>17.06.2026</u> 1. A petition dated 29.05.2026 has been filed on behalf of petitioners Dilkhush Roy and others pressing withdrawal of the bail petition dated 04.05.2026. The case record is not listed today. The next date of this case is 05.08.2026. The case record is taken on board and listed today for hearing on the petition. 2. Learned counsel for the petitioners submits that accused persons Radha Devi and Kajal Devi have already been granted bail by this Court <i>vide</i> order dated 16.03.2026, and bail bonds have also been furnished on their behalf. It is further submitted that due to inadvertence, another bail petition dated 04.05.2026 was filed on behalf of Radha Devi, Kajal Devi, Dilkhush Rai, Lalo Rai @ Lale Rai, Nitu Devi and Purtam Devi. Counsel points out that Dilkhush Rai and Lalo Rai @ Lale Rai are not named in the FIR, and therefore, to rectify the mistake, the present petition dated 29.05.2026 has been filed seeking withdrawal of the bail petition dated 04.05.2026. 3. Learned Special Public Prosecutor has not objected to the prayer for withdrawal of the bail petition dated 04.05.2026. 4. On perusal of the case record, it appears that a surrender-cum-bail petition was filed on 04.05.2026 on behalf of Dilkhush Roy @ Dilkhush Kumar, Lalo Roy @ Lale Rai, Radha Devi, Kajal Devi, Nitu Devi and Purtam Devi. It is also evident from the order dated 17.04.2026 that accused persons Radha Devi and Kajal Devi have already been granted bail in connection with Naugachia SC/ST P.S. Case No. 23 of 2025, and bail bonds have been furnished on the same day. It thus appears that due to mistake, another bail petition was filed on their behalf. Accordingly, learned counsel has filed the present petition dated 29.05.2026 seeking withdrawal of the bail petition dated 04.05.2026.
