This application for regular bail u/s 483 of the BNSS is filed on behalf of the petitioner namely Pritam Kumar, who is in judicial custody since 27.02.2026 in connection with Tilkamanjhi P.S. Case No. 148/2025 for the offence punishable u/s 303(2) B.N.S. 2. On behalf of the petitioner a certificate has been given at para 2 of the bail petition that earlier no bail application in any form has been filed either before the Sessions Court or before the Hon'ble High Court, Patna. Petitioner has also mentioned in para 3 of the bail petition that he has criminal antecedents in Pathargama P.S. Case No. 143/2021, Pathargama P.S. Case No. 184/2021, Pathargama P.S. Case No. 11/2024, Pathargama P.S. Case No. 161/2025 and Sabour P.S. Case No. 46/2024. 3. Heard, the learned counsel for the petitioner and the learned A.P.P. 4. Brief fact of the case is that the informant Pankaj Kumar Sharma has filed FIR alleging that on 25.06.2025 at around 02:50 o'clock he had come for treatment of her niece to Dr. Soman Chatterjee's clinic. It is further alleged that he had parked his Honda Shine SP 125 CC bike bearing registration No. BR11AD 9466 in front of the clinic by locking his handle and when he returned at 04:10 o'clock from the waiting room of the clinic, his bike was missing. He searched nearby places but he could not find any trace of his bike. 5. The Ld. counsel for the petitioner argued that the petitioner is innocent and has not committed any offence and he has been falsely implicated in this case. It was

further argued that petitioner is not named in the FIR. It was further argued that petitioner is in custody since 27.02.2026. It was further argued that nothing has been recovered from his possession. It was further argued that entire allegation is false and concocted, hence, petitioner deserves bail.

6. On the other hand, the Ld. A.P.P. has opposed the prayer for bail.

7. Perused the case diary and record. FIR has been lodged against unknown person. In entire case diary nowhere it has come that the petitioner has stolen the alleged motorcycle. Charge-sheet against the petitioner has already been submitted and cognizance is taken against him and therefore there is no chance of tampering with the evidence. No purpose would be served if the petitioner is kept in further judicial custody. The petitioner has remained in custody since 27.02.2026. The petitioner is further ready to abide by all the terms and conditions as may be imposed for grant of bail.

8. Considering the aforesaid fact and circumstances and the incarceration period, I am inclined to grant bail to the petitioner. Accordingly, the bail application of the petitioner is hereby allowed.

It is ordered that the petitioner be released on bail subject to his furnishing bail bond in the sum of Rs. 10,000/- (Rupees Ten Thousand) with two sureties in the like amount each to the satisfaction of the Court and subject to the condition that the petitioner shall furnish the bail bond after framing charge.

9. Any observation made herein above is not an opinion on the merits and the same is only for the purpose of the instant bail petition.
