ORDER

The petitioners aforementioned in apprehension of their arrest have filed an application seeking protection from arrest in Parbatta P.S. Case No. 194/2025 in which they are accused. This case was registered under Sections 126(2), 115(2), 118(1), 74, 110, 352, 3(5) B.N.S. against them. Copy of petition has already been served upon the Ld. Addl.P.P.

2. Heard Ld. Counsel for the petitioners and Sri P.N. Sah Ld. Addl. P.P. for State.

3. The grounds under which the petitioners have made their prayer that there is no type of bail petition either earlier file nor pending before Hon'ble High Court, Patna nor gracious court. It is further submitted that the petitioners are quite innocent and they have committed no offence. It is also submitted that prosecution case is maliciously false and concocted out of land dispute and there is no specific allegation against the petitioners and there is no date of occurrence, place of occurrence and time of occurrence mentioned in the F.I.R. and the petitioner also institute F.I.R. against the informant and her family members vide Parbatta P.S. Case No. 195/2025. It is also submitted that the petitioners are ready to compliance all terms and conditions which are laid down u/s 482 B.N.S.S. and the petitioners never left India without permission of Ld. Court and the petitioners undertake that he appear when and where the Ld. Court will be required.

4. The Ld. Addl.P.P. has opposed the prayer of bail of the petitioners.

5. As per factual matrix of the case the allegation of informant, namely, Chitrarekha Devi is stated that the accused petitioner, namely, Guddu Mishra, Nandini Devi, Chandan Kumar, Kundan Kumar, Asmita Kumari, all of them are forcibly constructed a house on the informant's hand, while the matter is in the Court. When protested, they beat the informant and her son and knocked them down. During this, the informant's head got damaged, she somehow managed to save her life in a damaged condition.

6. On the basis of written application of the informant, namely, Chitrarekha Devi Parbatta P.S. Case No. 194/2025 dated 09-12-2025 under Sections 126(2), 115(2), 118(1), 74, 110, 352, 3(5) B.N.S. was registered.

7. As directed case diary of this case has been produced. Perused the same. It transpires from perusal of case record there is land dispute between both parties. It also transpires that as per injury report the injury is simple in nature and there is no criminal history against the petitioners. Further investigation is still going on.

8. Regard being had to the aforementioned discussions, it is ordered that in the event of arrest or surrender of the petitioners whichever is earlier, within fourteen days of communication of this order to the Court of Ld. A.C.J.M.-III, Naugachia, let the petitioners be released on bail on furnishing two sureties of rupees fifteen thousand (15,000 x 2) subject to condition that surety shall be one close relative of the petitioners and petitioners shall co-operate in the trial and shall be properly represented on each and every date fixed by the Court and shall remain physically present as directed by the court and the petitioners will not tamper with the evidence or the witnesses. However, the acceptance of bail bonds in terms of the above mentioned conditions fulfilled by the petitioners as laid down all to the satisfaction of the Court of Ld. A.C.J.M.-III, Naugachia.
