The petitioner aforementioned is in judicial custody following her arrest on 12-05-2026 in Naugachia P.S. Case No. 214/2025 registered under Sections 103(1), 3(5) B.N.S. & 27 Arms Act is praying for his release by filing a petition. The copy of which has already been served upon the Ld. Addl. P.P. Both the Ld. Counsels are present.

2. Heard Ld. Counsel for petitioner and Sri P.N. Sah Ld. Addl. P.P. for State.

3. The Ld. Counsel for the petitioner submits that no bail petition filed either in the Court of Principal District & Sessions Judge, Bhagalpur or Hon'ble High Court, Patna except this one. It is further submitted that the petitioner is quite innocent and he has committed no offence and the prosecution story is maliciously false and concocted out of dirty village politics. It is further stated that no any eye witness to support the prosecution story and no any specific overtact against the petitioner and nothing has been recovered from the possession of the petitioner. It is also submitted that the petitioner is student and there is no any chance of absconding or delaying the trial.

4. The Ld. A.P.P. has vehemently opposed the prayer of the petitioner.

5. As per factual matrix of the case the allegation against the petitioner is that on 07-07-2025 at about 8 P.M. the informant's son, namely, Sarjan Kumar was with his brother Rahul Kumar in the south garden of Bajrang Bali Sthan located in village Tetri. In the same sequence, regarding a dispute over money with the other persons, namely, Vipin Singh, Sajan Kumar, Basuki Kumar, Raja Kumar, Manish Kumar, Ashish Kumar, Raja Kumar, Sachin Kumar Singh @ Murga, Ankaj Kumar Ram, Dilkhush Kumar Ram all the accused persons came with weap[ons and bullets in their hands and then grabbed the informant's son Sarjan Kumar and then dragged him into the garden and threw him to the ground and Kundan Kumar, Basuki Kumar, other unknown persons shot the informant's son with pistol. Seeing this, Rahul Kumar ran home from the place of

occurrence and somehow he reached his home and told the family members that all the accused persons killed Sarjan Kumar. When the informant and his family members came to the place of occurrence they saw Sarjan Kumar lying down in the garden, covered with blood. The informant and his family members picked him up and taken into the Naugachia Hospital. During treatment, Sarjan Kumar was declared dead by the concerned doctor. All the above mentioned accused persons killed the informant's son.

6. Heard both sides. Perused the written report of informant Subhash Ray addressed to S.H.O. of Naugachia P.S. Case No. 214/2025 under Sections 103(1), 3(5) B.N.S. & 27 Arms Act.

7. Heard both sides perused the F.I.R. it transpires from contents of the F.I.R. that petitioner is named in the F.I.R. and All the witnesses are supported the prosecution case and after perusal of the Case Diary direct allegation against the petitioner and he is directly involved in this case. It also transpires that the petitioner the petitioner is the member of unlawful assembly. As per para 118 of the case diary Charge-sheet has been submitted vide Charge sheet No. 437/2025 dated. 28.09.2025 under Sections 103(1), 3(5) B.N.S. & 27 Arms Act.

8. Regard being had to the discussions made above I am not inclined to enlarge the petitioner, namely, Raja Kumar @ Raja Babu S/o Lakhan Singh on bail. Hence, his prayer for bail is stands **Rejected**.
