ORDER

The petitioner aforementioned in apprehension of his arrest has filed an application seeking protection from arrest in Gopalpur P.S. Case No. 120/2025 in which he is accused. This case was registered under Section 109 B.N.S. against him. Copy of petition has already been served upon the Ld. Addl.P.P.

2. Heard Ld. Counsel for the petitioner and Sri P.N. Sah Ld. Addl. P.P. for State.

3. The grounds under which the petitioners have made their prayer that there is no type of bail petition either earlier file nor pending before Hon'ble High Court, Patna nor gracious court and the petitioner has no criminal history. It is further submitted that the petitioner is quite innocent and he has committed no offence. It is also submitted that the petitioner has falsely been implication in this case due to family distribution and suspicion and according to F.I.R. date of occurrence is on 31-03-2025 but F.I.R. lodged on 20-04-2025 which is inordinate delay and no any satisfactory explanation mentioned in the application dated. 19-04-2025. It is also submitted that no any intention to kill the informant and the petitioner is the husband of the informant and no any previous complaint regarding family distribute or regarding conjugal life and no any eye-witness to support the prosecution story. It is also contended that the petitioner is only one male member in his family and the petitioner is also ready to file the sufficient surety for anticipatory bail.

4. The Ld. Addl.P.P. has vehemently opposed the prayer of bail of the petitioner.

5. As per factual matrix of the case the allegation of informant, namely, Lilavati Devi is that on 31-03-2025 at about 06:30 P.M. the informant's husband Bilash Sharma @ Vilo Sharma the accused petitioner came to the house and from behind when the informant cooking, the accused petitioner came from the back and assaulted the informant with knife with the intention of killing her. After that she became unconscious. Then the informant's son came out from room and went to save his mother. In that time, the accused petitioner also started assaulting the informant's son, namely, Deepak Kumar, then all the family members took the informant and her son to the hospital

after that they were referred to the Bhagalpur for better treatment. After their treatment the accused petitioner threatening the informant over the phone that if she complaint this incident to the police he would kill her and her son. After that the informant lodged an F.I.R. before the police.

6. On the basis of written application of the informant, namely, Lilavati Devi Gopalpur P.S. Case No. 120/2025 dated 19-04-2025 under Section 109 B.N.S. was registered.

7. As directed case diary of this case has been produced. Perused the same. It transpires from perusal of the F.I.R. direct allegation against the accused petitioner, namely, Bilash Sharma @ Vilo Sharma. It also transpires that as per para 40 of the case diary stated the injury report, the injury is grievous in nature. Further investigation is still going on.

8. Regard being had to the aforementioned facts I am not inclined to admit the petitioner, namely, Bilash Sharma @ Vilo Sharma S/o Brahmadeo Tatma @ Brahmadeo Sharma on bail. Accordingly his prayer for anticipatory bail is stands **Rejected**.
