Patar Ram snatched the chain of gold from informant's daughter.</p> <p>4. Learned counsel for the petitioners submitted that no other bail petition, either ABP or BP has been filed or pending on behalf of the petitioners prior to the present one, in this Sessions Division or before the Hon'ble High Court. I have heard rival submissions of both sides and perused the case record. It transpires from perusal of injury report of Phuljharo Devi, the wife of informant, that the injuries found on her person, are opined to be simple in nature and laceration with swelling and tenderness on left side of head and bruises over right side of face has been found on the person of Halkano Devi, the mother of informant, regarding opinion has been kept reserved till yet. It is also evident from perusal of 'Fardbeyan' that the petitioners are non assailant and there is no specific allegation against them. The petitioners are men of clean antecedent and ready to comply with any condition imposed by this Court.</p> <p>7.
