<p><b>Contd.</b> <b>11.03.2026</b></p>	<p>for causing death within 7 years of marriage inside matrimonial home and there is allegation of demand of dowry and torture against accused persons. Bail petitioners herein are cousin brother and cousin sister of of main accused Om Gupta.</p> <p>4. Ld. counsel for the petitioners submitted that neither anticipatory bail nor regular bail filed or pending earlier on behalf of these petitioners in this case. Ld. counsel further submitted that the co-accused cousin brother and cousin sister of main accused Om Gupta have been granted bail by this Ld. Court, moreover, main accused Om Gupta suffering from serious ailment of Kidney and from very beginning of the marriage, deceased alongwith Om Gupta residing in Delhi and recently shifted in parental village and petitioners herein falsely implicated in this case, they are living separately with the family of Om Gupta. It is evident that accused persons have been implicated in this case based on fictitious and concocted story without any rhythm and reason, hence, bail of the petitioner may be allowed.</p>

Public Prosecutor vehemently opposed the bail plea of the petitioners and submitted that within 7 years of marriage death of the victim Nitu Kumari took place inside matrimonial home, hence, bail of the petitioners should be dismissed.</p> <p>6. I have heard the rival submission of both parties, perused the case record in this case, petitioners are cousin brother and cousin sister of main accused Om Gupta, whose marriage solemnized with deceased in the year 2020, is undisputed fact. Parents of main accused Om Gupta was staying in Delhi prior to year 2000 and father of main accused Om Gupta left for heavenly abode in the year 2005 and his mother left heavenly abode in the year 2001 during her ailment in Delhi at Ambedkar Hospital, Rohini and the same fact un- rebutted and main accused Om Gupta also recently shifted himself to ancestral village. From these facts it is clear that the petitioners being cousin brother and cousin sister of main accused Om Gupta were living separately and general and omnibus allegations made against them. Considering the facts and circumstances of this case and also the fact that petitioners were living separately even from the parents of main accused Om Gupta, who is husband of deceased Nitu Kumari hence, bail of the petitioners namely, <b>1. Pappu Sah @ Sanjeet Kumar, 2. Kanchan Sah @ Kanchan Kumari is allowed</b> and it is ordered that in the event of arrest/surrender they will be enlarged on anticipatory bail on furnishing bail-bonds of Rs.10,000/-(Ten thousand) each with two sureties of the like amount each to the satisfaction of the learned court below within four weeks of this order subject to the conditions as laid down u/s 482(2) BNSS. Subject to the condition that the petitioners shall make themselves available for interrogation by a police officer as and when required and the petitioners shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade them from</p>
