Record put up from office today for hearing on surrender-cum-bail petition dated 11.03.2026 filed on behalf of petitioner named above, who voluntarily surrender before the Court and is taken into custody in connection with **Buxar Industrial P.S. Case No. 10/2024** registered u/s 147, 149, 341, 323, 307, 379, 504 of I.P.C.

Copy of bail petition has already been served to the Ld. Addl. P.P. for the State.

Learned Counsel for petitioner submits that, earlier the petitioner was granted bail by learned C.J.M, Buxar on 13.02.2024 but due to lack of knowledge about the dates, he could not appear before the Court for framing of charge due to which her bail bonds has been cancelled on 09.10.2025 and N.B.W. was issued against her and other co-accused persons on 13.10.2025. The co-accused persons have been granted bail by this Court on 10.12.2025 and 23.12.2025. This is first misuse of privilege of bail by the petitioner. Therefore, petitioner also deserves to be enlarged on bail.

Learned Additional P.P. for the State vehemently opposed the bail petition on the ground that, the petitioner has misused the privilege of bail.

Perused the case record, from perusal of same it transpires that, the petitioner was granted bail by learned C.J.M, Buxar on 13.02.2024. After commitment, this record was received to this Court on 04.07.2025. Since 08.07.2025 the record is pending for hearing on framing of charge. The petitioner remained absent due to which her bail bonds were cancelled on 09.10.2025 and N.B.W. was issued against her on 13.10.2025.

Having considered the submissions made by the Counsels and in the aforesaid facts and circumstances of the case, the present bail petition of petitioner

named above is **provisionally allowed**. Let, the petitioner named above be provisionally released on bail till 30.03.2026 on furnishing **bail bond of Rs.10,000/-** with two sureties of the like amount each to the satisfaction of this Court with condition that, **she shall be physically present before the Court on next fixed date i.e. 30.03.2026 for framing of charge.**
