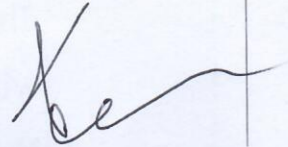

| <u>02.05.2026</u> | <p>Suit is listed today for order on petition dated 10.07.2025 of plaintiff wherein prayer has been made for direction for comparison of thumb impression of applicant with thumb impression on compromise filed in Title Suit No. 172/1993 by expert. It is submitted that this suit is filed for declaring compromise decree and judgment in said suit as invalid. It is pleaded that he has never placed his thumb impression on any such documents. He was also not adduced as witness in the suit.</p> <p>Defendant has filed his reply on 08.04.2026 wherein he has objected on the petition on various ground including ground that plaintiff has filed Title Suit No. 326/2012 in Court of Sub-judge, Buxar by concealing decree and judgment in Title Suit No. 172/1993. Said Title Suit No. 326/2012 was dismissed under Order 7 Rule 11. Plaintiff has not come with clean hand but with intention to harass the opponent. It is stated that thumb impression of applicant on plaint of Title Suit No. 326/2012 may also be compared with thumb impression on 172/1993 by Government Expert. It is also pleaded that on these grounds, prayer has been made for dismissal of petition.</p> <p>Heard the parties &amp; perused the records. It is noted that no material objection is there on record. To ascertain the truth behind the contention of applicant. The petition is allowed under contest without cost.
