ORDER

07. 13.03.2026. Heard the learned counsel for petitioner as well as learned P.P. for the state on the bail petition filed on behalf of above named petitioner, who is in custody since 05.01.2026 in connection with Nehra P.S. Case No. 01 of 2026 for offence U/S 317(5), 303(2) and 136 Bihar Electricity Act.

As per FIR, prosecution case in brief is that the accused persons namely Tulsi Kumar Mandal and Polo Sadai have been arrested on charges of stealing and transporting electrical materials.

Learned counsel for the petitioner submitted that the petitioner is innocent and he has committed no offence. It is further submitted that petitioner has been implicated in this case due to party politics. He further submitted that the nothing has been recovered from the possession of the petitioner. It has further submitted that no case is made out against the accused petitioner. He further submitted that the petitioner has no any criminal antecedent. The accused petitioner is in jail custody since 05.01.2026. It is, therefore, prayed to enlarge the petitioner on bail.

The learned Public Prosecutor opposed the prayer for bail.

Heard the parties and perused the record. From perusal of case record, it is alleged against accused petitioner that he committed theft of electrical materials. Nothing has recovered from the conscious possession of the accused-petitioner. The

investigation of the case is completed and charge sheet has been submitted in this case. The accused petitioner has no any criminal antecedent. The accused petitioner is in jail custody since 05.01.2026.

Considering the aforesaid facts and circumstances as well as the period of custody already undergone, instant bail petition filed on behalf of petitioner is hereby **allowed** and petitioner is directed to be enlarged on bail on furnishing bail bond of Rs.10,000/- (Ten Thousand) with two sureties of the like amount each to the satisfaction of the learned court below with condition that he will not to commit such occurrence in future and he will cooperate in the trial of this case.
