ORDER

1. The present execution proceeding has been initiated for enforcement of the award dated **25.08.2022**, whereby the opposite party, namely **Shriram General Insurance Company Limited**, was directed to pay a sum of **Rs. 58,48,188/- (Rupees Fifty Eight Lakhs Forty Eight Thousand One Hundred Eighty Eight only)** along with **interest @ 7% per annum** from the date of filing of the claim petition till the date of actual payment. The award was required to be satisfied within **two months** from the date of the order.
2. Learned counsel for the Decree Holders submits that despite having full knowledge of the award as well as the pendency of the present execution case, the Judgment Debtor has neither appeared before this Court nor complied with the terms of the award.
3. Perusal of the order-sheet reveals that notice was duly issued to the Judgment Debtor, but no appearance has been made on its behalf. The execution case has been pending since the year **2023**, and the Judgment Debtor has failed to make any payment towards satisfaction of the award.
4. The conduct of the Judgment Debtor reflects a negligent and careless attitude towards compliance of the lawful order of this Court. In such circumstances, this Court is left with no alternative but to adopt coercive measures for enforcement of the award.
5. Accordingly, it is hereby directed that the operation of the following bank accounts of **Shriram General Insurance Company Limited** shall

remain **frozen** until the award amount is paid or until further orders of this Court:

6. The Office is directed to send a copy of this order to the concerned Branch Managers of the aforesaid banks for necessary compliance.
7. The concerned banks shall submit a compliance report before this Court after implementation of this order.
8. **Put up on the date fixed for compliance.**
