ORDER
13.03.2026

1. The Petitioner is praying for regular bail in connection with Kamtaul P.S. Case No. 145/2025 registered under Section 126(2), 115(2), 118(1), 103(1), 3(5) of the Bhartiya Nyaya Sanhita, 2023 (hereinafter referred to as 'BNS' for short). The Petitioner has been in judicial custody since **11.12.2025**.
2. Briefly stated, the allegation against the petitioner is that he along with co-accused persons committed murder of deceased Ram Vinod Thakur. There is direct allegation against the petitioner to have assaulted the deceased by means of sharpened wood on his head and in pursuance of injury thereof, the deceased died.
3. Learned counsel for the petitioner submits that he is an innocent and has not committed any offence as alleged. He further submits that he has no criminal antecedent. In this backdrop, he prays for bail.
4. Learned Public Prosecutor has opposed the prayer for bail.

5. Heard the parties. Considered the submissions. Perused the material on record. The petitioner is named in the FIR. There is direct allegation against the petitioner to have assaulted the deceased. The injured died. Hence, precisely considering the nature of accusation, gravity and severity of the offence coupled with punishment provided therein, I am not inclined to enlarge him on bail.
6. Accordingly, the present petition stands **dismissed**.
