2. Heard on behalf of respective party.

Learned counsel for the petitioner submitted that there is case and counter case in between both the parties and the case filed by the petitioners vide Singhwara PS Case No.210/2017 against Opposite 2nd party is pending in the court of Miss. Shail Kumari, JMFC, Darbhanga vide T.R.No.1669 of 2025 for evidence. He further submitted that the counter case filed by Nagendar Kumar Chaudhary, opposite 2nd party accused in a case of petitioner, who is informant in Singhwara PS Case No.211/2017 dated 11-12-2017 is pending in the Court of learned Addl. Sessions Judge-X, Darbhanga vide S.T.No.191/2019 for evidence.
