**ORDER**

**11.05.2026**

1. The petitioners above named sought anticipatory bail in connection with Bhalpatti P.S. Case No 54/2025 registered for the offences under Section 62, 64(1) of the Bhartiya Nyay Sanhita (hereinafter referred to as 'BNS' for short).
2. Learned counsel appearing on behalf of the petitioners submitted that they were innocent and had not committed any offence. It was further submitted that petitioners had not filed bail petition of any sort earlier this court or either before any superior court. It was also submitted that the petitioners had no criminal antecedent and had been falsely implicated in this case due to village politics. It was also submitted that the petitioners had not named in the FIR. It was further alleged that from perusal of FIR and case diary no any positive evidence against petitioners. It was also alleged that the case had been compromised between the parties and compromise petition had also been filed separately. It was submitted that the petitioner were ready to abide by the condition(s) imposed upon them by the learned court. The learned counsel prayed for grant of anticipatory bail to the petitioners.
3. Learned Public Prosecutor opposed the petition and prayed to reject it.
4. Heard both the sides, perused the case record and the Learned Trial Court Record.
5. The prosecution case according to FIR in brief is that the accused Faisal called the prosecutrix on phone and asked her to come to his house. When she reached there she found him alone. Faisal locked gate and attempted to molest her.
6. Petitioners are not named in the FIR. They are family members of the main accused Qamre Faisal. There is no allegation against them in the FIR, nor the pros-

ecutrix imputed anything against the petitioners in her statement u/s 183 of the BNSS. The petitioners have no criminal antecedents.

7. In the facts and circumstances as discussed above, the instant anticipatory bail petition filed on behalf of the petitioners namely **1. Mumtaz Begum, 2. Zarina Khatoon, 3. Md. Ali @ Ahmed Ali, 4. Manthakib and 5. Intekhab @ Md. Intekhab**, is hereby **allowed**. In the event of arrest or surrender by the petitioners within 21 (Twenty One) days of receipt/production of this order, they are directed to be released on furnishing bail bond of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of Learned Jurisdictional Court concerned with an undertaking as stipulated under Section 482(2) of the BNSS.
8. It is made clear that this order has no bearing on the merits of the case.
9. Let a copy of this order be sent to the concerned jurisdictional court.
10. Let this case record be deposited in the Record Room, Civil Court, Darbhanga after all due diligence.
