ORDER

1. This petition is for suspension of the sentence of imprisonment awarded by the trial Court against the petitioners pending disposal of the appeal. 3. In the result, the petition is allowed and the sentence imposed by the lower court in CC No.146 of 2017, dated 14.10.2022 against the petitioners is hereby suspended till pending disposal of appeal on the same terms and conditions as imposed by the trial Court.
