A bail petition has been filed on behalf of accused namely 1. Sundesh Paswan 2. Jitesh Paswan @ Nitish Paswan 3. Amrej Paswan. Copy served to S.D.P.O. for the state. Accused persons are taken into custody. The Ld. Counsel for defence has submitted that petitioners were all along on bail during investigation and never misused the privilege of bail. Tat they are surrendering voluntarily on knowledge of cognizance. That no process has ever served upon petitioners. Hence be enlarged on bail. Ld. S.D.P.O. an Ld. Council for informant opposed the bail petition vehemently. Heard both sides and perused the case record. It appears that petitioners were granted bail during investigation in the light of order of A.D.J. Benipur vide order dated 13-11-2024 passed in A.B.P.180/2024. Later on bail of these petitioners was cancelled by the Ld. A.D.J. Benipur vide order dated 22-07-2025 passed in Cr. Mis. 4/2025 and they were directed to surrender before lower court within three weeks of the order, but they didn't complied with that order. They are surrendering on issuance of N.B.W. Under such facts and circumstances I am not inclined to enlarge the petitioner on bail. Hence bail petition of accused 1 Sundesh Paswan 2. Jitesh Paswan @ Nitish Paswan 3. Amrej Paswan stands Rejected.
