**State of Bihar (Through Chandrakala Devi) v. Sanjay Yadav & Ors.**

**Order**

09.03.2026	<p>The case is called out. All the four accused persons are present along with their Ld. Counsel. Ld. S.D.P.O. is also present on behalf of the State. This record is put up today for order on the point of joint compromise petition dated 15.09.2025 filed by the informant <b>Chandrakala Devi</b> and the four accused persons namely <b>1. Sanjay Yadav, 2. Manoj Yadav, 3. Ramanjee Yadav</b> and <b>4. Bholu Yadav</b>. Copy of compromise petition is served upon Ld. S.D.P.O. for the state. The Compromise petition is signed by informant as well as the aforesaid accused persons and their Ld. Counsel have also made their signature on the compromise petition.</p> <p>The informant namely <b>PW-1 Chandrakala Devi</b> has been examined on the point of compromise on 11.12.2025. She has stated in her cross examination that she has compromised in this case with the accused persons with her own free will and has signed on the aforesaid compromise petition submitted before the court. She further stated that he does not wish to contest this case further or adduce any more evidence in this case. Injured/victim and son of informant, <b>PW-2 Hiranand Yadav</b> has also been examined on the point of compromise on 19.12.2025.</p> <p>Heard both the parties on the point of compromise. Perused the entire case record. On perusal, it transpires that the present case arises from fard-bayan of the informant Chandrakala Devi, based on which FIR no. 267/2020 was</p>	2

registered in Biraul P.S. against the aforesaid accused persons on 08.08.2020 u/S. 341, 323, 324, 325, 307 and 504 read with S. 34 of the I.P.C. Thereafter, the charge sheet no. 15/2021 was filed on 10.01.2021 u/S. 341, 323, 324, 326, 354 (B) and 504 read with S. 34 of the I.P.C. Consequently, cognizance was taken on 25.02.2021 against the aforesaid four accused persons u/S. 341, 323, 324, 325, 354(B) and 506 read with S. 34 of the I.P.C. Thereafter, charges were framed against the aforesaid four accused persons on 15.09.2025 u/S. 341, 323, 324, 325, 354(B) and 506 read with S. 34 of the I.P.C.

After considering above facts and circumstances, this court is of the view that **sections 341, 323 and 506 of the I.P.C are compoundable at behest of the victim** as per the table appended to sub clause (1) of section 320 of the Criminal Procedure Code, 1973. **Section 325 of the of the I.P.C. is compoundable with the permission of the court** as per the table appended to sub clause (2) of section 320 of the Criminal Procedure Code, 1973. Only Section 354(B) is attracted in this case which is non-compoundable in nature. However, as per the examined prosecution witnesses, who denied the specific involvement of accused persons in the said occurrence. hence the aforesaid allegation of S. 354 (B) of IPC is not proved beyond reasonable doubt which is the standard of proof required in criminal jurisprudence.

Therefore, this joint compromise petition dated 15.09.2025 is being accepted in the interest of justice and the aforesaid offences against the four accused persons namely **1. Sanjay Yadav, 2. Manoj Yadav, 3. Ramanjee Yadav and 4. Bhola Yadav stands compounded.**

#### **ORDER**

**Hence, the compromise petition dated 15.09.2025 is allowed and the four accused persons namely 1. Sanjay Yadav, 2. Manoj Yadav, 3. Ramanjee Yadav and 4. Bhola Yadav stands hereby acquitted u/s 320(8) of Cr.P.C. from the charges of offences punishable under sections 341, 323,**

**324,325, 354(B) and 506 read with S. 34 of the I.P.C.** Their bailors are also discharged from the liabilities of their respective bail bonds.

The Office is directed to recall all the processes issued by this court (if any) and deposit the case record to the Record Room within the stipulated time, after following all the procedural formalities.
