ORDER

This anticipatory bail petition has been filed on behalf of the above named petitioners, who are apprehending their arrest in connection with Dumariyaghat P.S Case No. 48 of 2024, U/s- 341, 323, 307, 379, 504 read with 34 of I.P.C..

Heard, the Ld. counsel appearing on behalf of petitioners and Ld. P.P.(I/C) on behalf of State/O.P.

The prosecution case in brief as per the written application of the informant is that on 03.03.2024 these petitioners and other FIR named co- accused and 7-8 unknown persons committed loot of Rs. 50,000/- and also assaulted him. It is further alleged that accused persons have also assaulted the drivers Kishore Mahto, Amit Kumar and Rahul Yadav..

Ld. counsel appearing on behalf of accused petitioners has submitted that petitioners are innocent and have not committed alleged offence and they have falsely been implicated in this case. No other regular or anticipatory bail petition has ever been filed on behalf of the petitioners either before this court or any superior court. Petitioners have no criminal antecedent. The allegations whatsoever levelled against the petitioners are false, fabricated, manipulated and concocted. All the alleged sections levelled against the petitioner are bailable except 307 and 379 of I.P.C. Ld. counsel on behalf of petitioners has submitted that I.O. has submitted the charge-sheet against the co-accused Vicky Puri and showing the present accused petitioners as not sent up for trial but learned trial court has taken cognizance against these petitioners along with co-accused as per F.I.R. Petitioner is ready to abide all the terms and conditions imposed by the court.

On other hand, Ld. Public Prosecutor(I/C) appearing on behalf of State opposed the

prayer for anticipatory bail.

Heard both sides and perused the record. From the perusal of record it transpires that there is omnibus allegation against the petitioners that they along with co-accused committed loot of Rs. 50,000/- and also assaulted the informant and drivers Kishore Mahto, Amit Kumar and Rahul Yadav. From perusal of injury report it transpires that the doctor has found that the injured sustained by the injured as simple in nature. From perusal of trial court record it transpires that I.O. has submitted the charge-sheet against the co-accused Vicky Puri and showing the present accused petitioners as not sent up for trial but learned trial court has taken cognizance against these petitioners along with co-accused as per F.I.R. Cognizance has already been taken in this case so there is a no chance of tampering with the evidence, moreover petitioners have no criminal antecedent.

Considering the aforesaid facts and circumstances of the case, nature of the allegation brought against the petitioner, I am inclined to give privilege of pre-arrest bail to above named accused petitioners. Accordingly, in the event of their arrest or surrender before the learned trial court within four weeks from the date of receipt of copy of this order, before the learned trial court, the above named petitioners are ordered to be released on anticipatory bail on furnishing bail bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of the like amount each subject to the satisfaction of the Ld. Court below in the aforesaid case and subject to the condition as laid down u/s 482(2) B.N.S.S. with further condition that petitioners shall remain present each and every date before the learned trial court till framing of charge.
