This anticipatory bail petition is filed on behalf of the petitioners, namely, (1) Ramji Sahani @ Ramjit Sahani, (2) Galu Kumar @ Golu Kumar, (3) Badri Sahani, (4) Saroj Devi, (5) Mukhiya Devi, (6) Awadhesh Sahani and (7) Sangita Devi, who are apprehending their arrest in connection with Harsidhi P.S. Case No. 794 of 2025 u/ss 103(1), 238 and 3(5) of Bharatiya Nyaya Sanhita, 2023 and 3/4 of Dowry Prohibition Act.

In para-2 of the anticipatory bail petition, it is mentioned that no other anticipatory or regular bail petition has ever been filed on behalf of the petitioners either in this Court or before the Hon'ble Patna High Court. As per para-3 of the anticipatory bail petition the petitioners have no criminal antecedent.

As per F.I.R., the informant's daughter was married to Jokhan Sahani in 2013 and her life was proceeding smoothly. Suddenly, all the accused persons named in the F.I.R. including the petitioners committed murder of his daughter in greed for dowry and disappeared the dead body. The informant and 112 police searched the dead body but found no trace.

The learned counsel for the petitioners has submitted that the petitioners are innocent and they have committed no offence. The petitioners are in-laws of deceased and they have no concern with the deceased as they are living separately. It is

further submitted that good sense has already been prevailed in between the parties. On these basis, it is prayed to allow this anticipatory bail petition.

The learned Public Prosecutor appearing on behalf of the State has opposed the prayer for anticipatory bail.

Heard both sides and perused the record. From perusal of the record, it transpires that the petitioners are named in the F.I.R. with the allegation of committing murder of informant's daughter in greed for dowry and disappeared the dead body. As per para-2, 8 and 9 of the case diary, the informant in his restatement and the witnesses have corroborated the version of F.I.R. and supported the prosecution case. As per para-3 of anticipatory bail petition, all the petitioners have no criminal antecedent. As per para-34 of the case diary, criminal antecedent report of only petitioners Ramji Sahani, Awadhesh Sahani and Mukhiya Devi is mentioned as they have no criminal antecedent and regarding criminal antecedent of rest accused/petitioners nothing has been mentioned. As per para-35 of the case diary, investigation is still ongoing.

In the facts of the case as discussed above and keeping in view the nature of allegation and gravity of offence, I am not inclined to give privilege of pre-arrest bail to the petitioners. Accordingly, the prayer for anticipatory bail of petitioners, namely, **(1) Ramji Sahani @ Ramjit Sahani, (2) Galu Kumar @ Golu Kumar, (3) Badri Sahani, (4) Saroj Devi, (5) Mukhiya Devi, (6) Awadhesh Sahani and (7) Sangita Devi** stands rejected.

Let a copy of this order be communicated to the Superintendent of Police, East Champaran at Motihari to take necessary action against the erring I.O. for non-submission of criminal antecedent report of all the petitioner/accused in the case diary.
